# Restoring Power: Behind the Scenes During and After a Storm

**W**hen a storm hits, power outages can be more than an inconvenience—they can disrupt lives and raise serious safety concerns. At Little Ocmulgee EMC, restoring power quickly and safely is a responsibility we take very seriously. While many people see the lights go out and later come back on, there's an entire process happening behind the scenes to make it all possible.

The process of power restoration begins well before the storm arrives. Our team monitors severe weather systems and takes steps to prepare in advance, placing line crews on alert, fueling trucks, stocking supplies and reviewing emergency response plans. This preparation ensures that we can respond swiftly and safely.

When a storm moves through, safety is always our first priority. High winds and downed trees often bring power lines to the ground, creating hazardous conditions for the public and our employees. We urge members to stay far away from any downed lines and report them immediately; always assuming they are energized and dangerous.

When the height of the storm passes and it's safe for our crews to work, restoration efforts by our crews begin immediately by assessing the damage. This is a critical step. We inspect substations, transformers, poles and lines to identify the cause and scope of the outages. In many cases, we use outage-management systems, digital maps and drones to

evaluate damage more quickly and accurately.

Power restoration follows a carefully planned sequence. Repairs begin at the source—our substations. These facilities feed electricity to thousands of homes and businesses, so restoring them brings power back to the largest number of members. From there, we move on to main distribution lines, which carry electricity from the substations to communities. Finally, we address tap lines and service drops that bring power to individual homes or smaller groups.

## STEPS TO RESTORING POWER WHEN A STORM HAPPENS



This tiered system ensures the fastest and most efficient restoration possible. While it may be frustrating to see a neighbor's lights return before yours, it's often due to where your service falls in this restoration order.

During widespread outages, Little Ocmulgee EMC may receive help from other electric cooperatives or contract crews through a mutual aid system. These partnerships allow us to scale up quickly and shorten the time it takes to bring everyone back online.

Communication is also a key part of our storm response. We provide updates through our website, social media, outage maps and mobile alerts. While estimated restoration times may change as crews discover new issues in the field, we work hard to keep our members informed throughout the process.

Once the initial power restoration is complete, our job isn't finished. Crews continue to make permanent repairs, replace damaged equipment and clear debris to ensure long-term reliability.

Restoring power after a storm is a challenging task that requires teamwork, coordination and a deep commitment to our community. From our field crews and dispatchers to our support staff and cooperative members, everyone plays a role.
