- **Usage Data:** Information on how you interact with the T4U platform, including IP address, browser type, and device information.
 - **Cookies:** Data collected through cookies and similar technologies to enhance your user experience.

3. How We Use Your Data

We use your personal data to:

We may share your data with:

- **Legal Authorities:** Where required by law or to protect our legal rights.

We ensure that all third-party processors comply with applicable data protection laws.

5. Data Retention

We retain your data only as long as necessary for the purposes outlined in this policy or to comply with legal requirements:

- **Account Data:** Retained while your account is active or as required by law.
 - **Payment Data:** Retained for financial record-keeping in accordance with applicable laws.
