

Privacy Policy for KEW Design, LLC

Overview

At KEW Design, LLC ("KEW Design," "we," "us," or "our"), we respect your privacy and are committed to being transparent about how we handle your personal information. This Privacy Policy explains what information we collect, how we use it, and your rights regarding that information when you visit our website.

We keep things simple: we do not sell, rent, or share your personal information with third parties for marketing purposes — ever.

1. Information We Collect

We collect only the information you voluntarily provide to us through our website's contact/inquiry form. This includes:

- **Your name**
- **Your email address**
- **Your message** (including any details about artwork inquiries or commissioned work requests)

We do NOT collect:

- **Payment or financial information** (all purchases are handled securely through Etsy)
 - **Sensitive personal information**
 - **Location or demographic data** (all shipping addresses are handled securely through Etsy)
 - **Website usage data or behavioral analytics**

2. How We Collect Information

We collect information only when you choose to contact us by submitting our inquiry form. We do not use cookies, tracking pixels, or analytics tools to monitor your visit to our website.

3. How We Use Your Information

The information you provide is used solely for the following purposes:

- **Responding to your inquiry** about artwork, availability, or pricing
- **Managing commissioned work**, including consultations, design discussions, and project updates
- **Communicating order or project status** with you throughout the process

We will never use your contact information to send you unsolicited marketing emails, newsletters, or promotional materials.

4. How We Store Your Information

Your inquiry information is stored securely within our business email system (Google Workspace). We retain your information for up to two (2) years from the date of your inquiry to allow for follow-up on commissioned work and ongoing client relationships.

After two years, your information is permanently deleted from our records unless an active business relationship or open project requires us to retain it longer, in which case we will retain only what is necessary.

5. Third-Party Services

While KEW Design does not share your personal information with third parties for marketing, our website does integrate with the following third-party platforms, each of which operates under its own privacy policy:

We take reasonable precautions to protect your personal information from unauthorized access, misuse, or disclosure. These measures include:

- Secure, password-protected email systems (Google Workspace)
- SSL encryption on our website (provided by Webflow)
- Limiting access to your information to only the business owner

While we take these precautions, please be aware that no method of internet transmission or electronic storage is 100% secure, and we cannot guarantee absolute security.

7. Your Rights

You have the right to:

- Access the personal information we hold about you
- Request correction of any inaccurate information
- Request deletion of your personal information at any time, subject to any legal or contractual obligations
- Withdraw consent for us to hold your information
