(a)! Warranty Statement

Archityne Limited (787612) ("**Archityne**") confirms that the relevant product or system supplied for the project will be warranted on a back-to-back basis on the same terms as the warranty provided by Archityne's applicable international manufacturer/supplier ("**Supplier**"). Such warranty is provided subject at all times to the scope, exclusions, limitations, maintenance requirements, claim procedures and other conditions set out in the Supplier warranty terms annexed hereto, or as otherwise provided together with the terms of this warranty certificate (the "**Supplier Warranty**"). This warranty is provided for the warranty period stated above from the date of practical completion or such other stated in the annexed Supplier Warranty.

This certificate is issued for the benefit of the project owner named in the project records and applies only to the products supplied by Archityne for the project described in this certificate. It does not extend to workmanship, installation defects, design issues, substrate failure, misuse, unauthorised modification, failure to follow installation or maintenance instructions, or any matter excluded by the Supplier Warranty. It may only be assigned with the prior written consent of Archityne failing which this warranty will be void.

(b)! Terms of Warranty

Only after Archityne has received payment for the product in full and on time, in compliance with Archityne's terms and conditions of trade, will this Warranty become operative and any delays arising will be deducted from the warranty period. If the project owner breaches such terms and conditions of trade will render this warranty void.

The claimant will be responsible for covering all costs related to the examination of any purported failure or degradation in the product if it turns out that Archityne or the product was not at fault.

Any corrective action conducted in connection with the Product without Archityne's prior written consent will render this warranty void.

With the exception of this warranty, Archityne makes no representations about the product and offers no guarantees, conditions, or warranties of any kind (including implied warranties, conditions, or assurances that can be lawfully excluded), and it disclaims all liability for any guarantees, conditions, warranties, representations, statements, or terms that are not specifically stated in this warranty. The warranty is provided to parties in trade and as such the Consumer Guarantees Act 1993 does not apply as the product is being supplied for business purposes, which you warrant to be the case on receipt of this warranty.

(c)! Supplier Warranty Terms

The Supplier's Warranty terms, technical requirements, care and maintenance obligations, notification obligations and claim procedures form part of this warranty. If there is any inconsistency between this certificate and the Supplier Warranty terms, the Supplier Warranty terms will prevail to the extent of that inconsistency.

This warranty should be read together with the applicable Supplier Warranty terms and any project-specific technical documentation, installation requirements, maintenance schedules and exclusions supplied by Archityne or the relevant international Supplier.

(d)! Notification Requirements

Under this warranty, Archityne will only be responsible if written notice is received within seven (7) days (time of the essence) of any failure or defect in the product being obvious or known. The claimant is responsible for making sure that Archityne or its nominee has a chance to examine the impacted region as soon as is reasonably possible following the notification.
