Risk profile



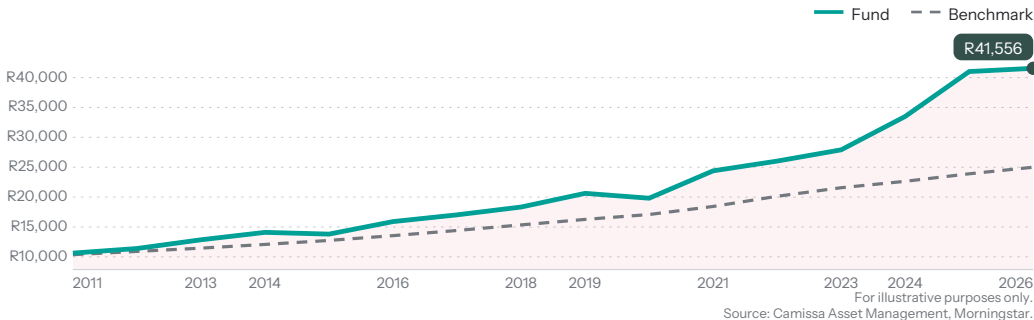
