Risk profile



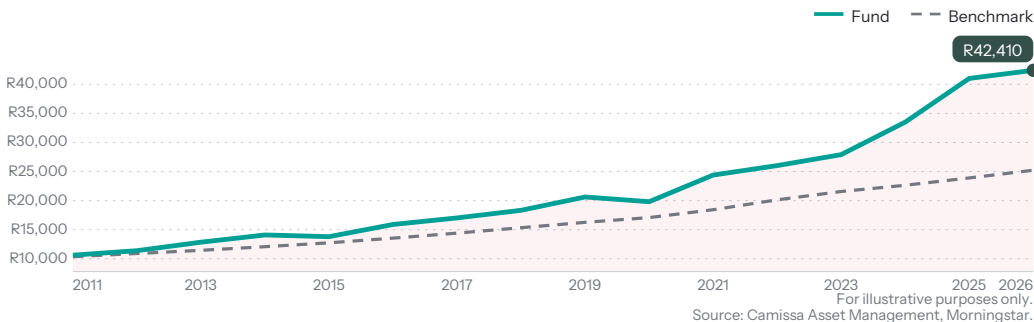
