Medical	Beck offers two medical plan options through UnitedHealthcare and Surest to help support your healthcare needs.	Enroll yourself, your spouse, and eligible dependents in the Health Savings Account Medical Plan or Surest Medical Plan.
Health Savings Account (HSA)	Save and spend tax-free dollars on eligible healthcare expenses when enrolled in the HSA Medical Plan. Beck contributes to your HSA.	Contribute up to IRS limits and receive a Beck contribution based on your coverage level.
Healthcare Flexible Spending Account (FSA)	Set aside pre-tax dollars to pay for eligible healthcare expenses.	Contribute up to \$3,300 annually if enrolled in an eligible medical option or if coverage is waived.
Dependent Care FSA	Pay for eligible childcare and eldercare expenses with pre-tax dollars.	Contribute up to \$7,500 annually for eligible dependent care expenses.
Dental	Comprehensive dental coverage through Cigna for preventive, basic, major, and orthodontia services.	Enroll yourself, your spouse, and eligible dependents.
Vision	Vision coverage through EyeMed for exams, glasses, contacts, and discounts on additional services.	Enroll yourself, your spouse, and eligible dependents.
Accident Insurance	Provides cash benefits to help offset expenses resulting from covered accidental injuries.	Choose Base or Plus coverage for yourself and eligible dependents.
Critical Illness Insurance	Pays a lump-sum benefit upon diagnosis of a covered critical illness.	Elect \$10,000, \$20,000, or \$30,000 coverage with dependent coverage available.
Hospital Indemnity Insurance	Provides cash benefits for covered hospital admissions and stays.	Choose Base or Plus coverage for yourself and eligible dependents.
Life Insurance	Beck provides company-paid Basic Life and AD&D coverage.	Basic coverage of 2x annual salary up to \$1,000,000 is provided automatically.
