## What is the purpose of this update?

This document tells you how the Aurora RetirementPlus Age 75 has performed and what fees were charged. The document will help you to compare the fund with other funds. Hive Funds Limited<sup>1</sup> prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

**Objective:** RetirementPlus Age 75 is a representation of the RetirementPlus life cycle investment option at the specified age.

**Strategy:** This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund.

## What are the risks of investing?

Risk indicator for the Aurora RetirementPlus Age 75:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

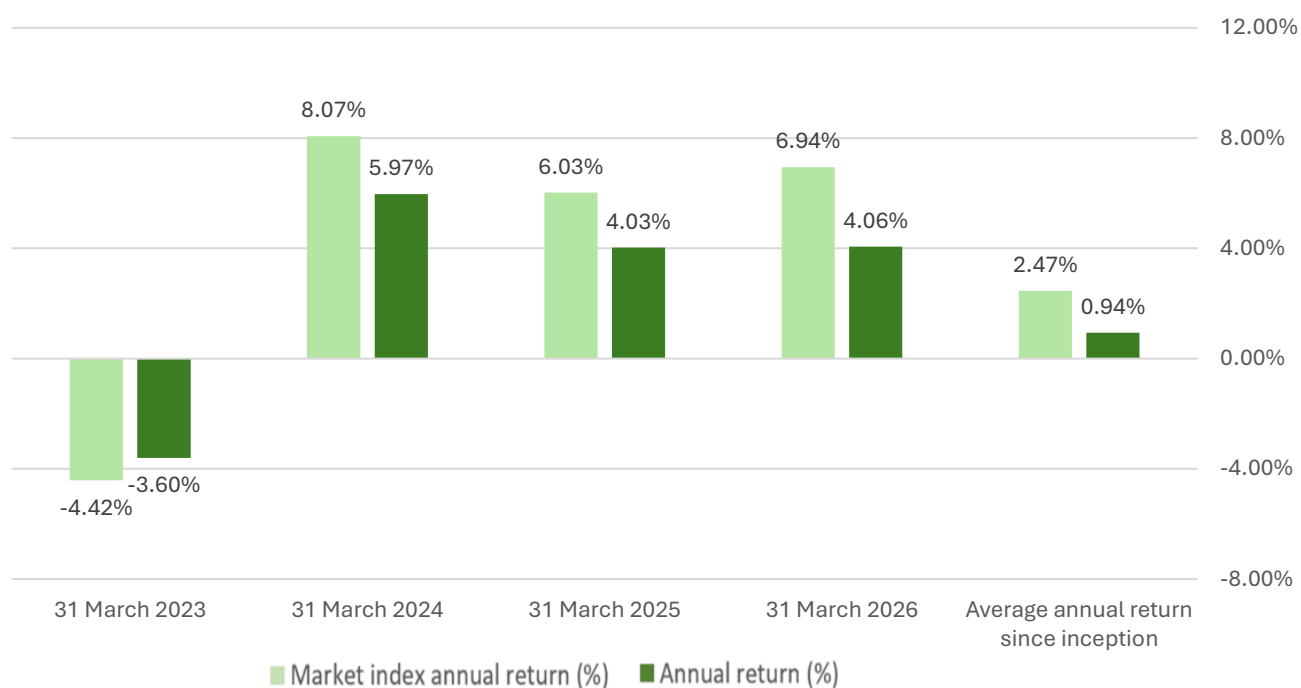
## How has the fund performed?

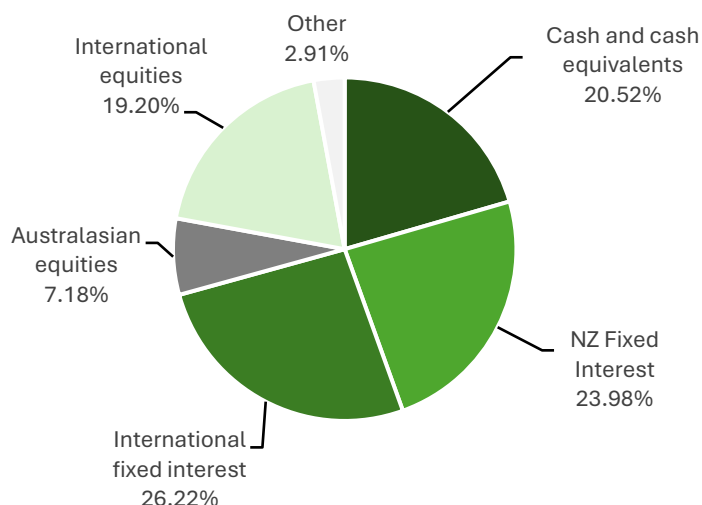
### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term. Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$477 (that is 4.77% of his initial \$10,000). Anthony also paid \$36 in other charges. This gives Anthony a return after tax of \$370 for the year.

<sup>1</sup> On 6 March 2026, Hive Funds Limited replaced FundRock NZ Limited as manager of the Aurora KiwiSaver Scheme.

<sup>2</sup> RetirementPlus has been in existence for less than 5 years. Risk indicators for this investment option are calculated using a combination of market index returns (1 April 2021 – 31 August 2021) and actual returns of the funds into which the strategy invests (1 September 2021 – 31 March 2026). The risk indicators may therefore provide less reliable indicators of the investment options' future volatility.

<sup>3</sup> This investment option invests 15% in the Aurora Growth Fund and 85% in the Aurora Conservative Fund and the fees shown reflect this investment split. "**Other management and administration charges**" includes estimates of certain charges incurred in the underlying funds in which the funds (named above) in this strategy invests. The estimate incorporates information provided by underlying fund managers as well as information sourced from the underlying fund's disclosure documents.

<sup>4</sup> "**Other**" includes forward currency contracts and unitised investments with a mix of various asset classes (NZ fixed interest and international fixed interest).
