1. Event Information

2. Vendor Space & Fee

Each vendor space measures 8 feet wide by 6 feet deep.
Vendor fee: \$2,500.00 for the full weekend (Friday–Sunday).
Space includes floor space only unless otherwise agreed in writing.
Vendors are responsible for their own displays, linens, electricity needs, and equipment unless otherwise arranged.
Full payment is due upon signing this Agreement unless a separate written payment plan is approved.
Vendor space is not secured until payment is received.

3. Setup & Breakdown

Setup:

Friday, May 1, 2026 from 9:00 AM – 5:00 PM.

All vendors must be fully set up before vending begins Friday afternoon.

Breakdown:

Vendors may not dismantle booths before 5:00 PM on Sunday, May 3, 2026.

4. Vendor Responsibilities

Vendor agrees to:

Keep booth space clean, professional, and within assigned boundaries.

Comply with all local, state, and federal laws.

Obtain any required licenses, permits, or insurance.

Maintain appropriate liability insurance coverage.

Conduct business in a professional and respectful manner.

Not sublease or share booth space without written approval.

Vendor is solely responsible for collection and payment of any applicable sales tax.

5. Permitted Items

Vendor agrees to sell only products or services described in their vendor application and approved by the Organizer. Organizer reserves the right to request removal of inappropriate, unsafe, or unapproved merchandise.

6. Payment & Cancellation Policy

Vendor fees are non-refundable unless the event is canceled by Organizer.

If Vendor cancels:

No refunds will be issued. Booth space may be reassigned.

If the event is canceled due to circumstances beyond Organizer's control (force majeure, government restrictions, venue cancellation, etc.), Organizer's liability is limited to refunding vendor fees collected.

7. Liability & Indemnification

Vendor agrees to indemnify and hold harmless OxyNation, its organizers, staff, volunteers, and the venue from any claims, damages, losses, or injuries arising from Vendor's participation in the event.

Vendor understands that participation is at their own risk. Organizer and venue are not responsible for theft, damage, or loss of vendor property.

8. Security

General event security may be present; however, vendors are responsible for securing their own merchandise and equipment.

9. Compliance with Venue Rules

Vendor agrees to comply with all rules and regulations set by The Golden Chariot.

10. Agreement & Electronic Acceptance

By selecting the required acceptance checkbox on the OxyNation website and submitting payment, Vendor acknowledges they have read, understood, and agree to all terms outlined in this Agreement.
