Introduction

New Gate to Peace Foundation ("NGTPF," "we," "us," or "our") operates the NGTPF website ("Website") available at <https://www.newgatepeacefoundation.org>. This Privacy Policy outlines our data collection practices, how we use personal information, and your rights as a user ("User," collectively "Users"). By using the Website, you acknowledge that you have read and understood this Privacy Policy. If you do not agree, please discontinue using the Website.

Your use of the Website is also governed by our Terms of Service.

Information Collected

NGTPF collects the minimum personal data necessary to process donations and communicate with Users. This may include:

- Personal Information: Name, email address, billing address, payment information, and any preferences or details voluntarily provided.
- Usage Information: Data on how Users interact with the Website, including page visits and search terms.

Data is collected through third-party services, including:

- Fundraise Up: Used for donation form processing.
- Payment Processors: Stripe, PayPal, and their subsidiaries handle payment transactions.
- DonorPerfect: Used for secure data storage.
- Campaign Monitor: Our email marketing service for newsletters and updates.

Use of Information Collected

We use the information we collect from you for the following purposes:

- To Provide Our Website and Services: Ensuring that the Website functions as intended and delivering services to Users.
- To Send Newsletters: Using your name and email address to keep you informed about NGTPF's activities and updates.
- To Respond to Inquiries: Addressing any questions or concerns submitted through our Website.
- To Improve User Experiences: Enhancing the usability and navigation of the Website.
- To Request Donations: Using your information to seek support for NGTPF's projects and causes.

- For Other Legitimate Business Purposes: Carrying out operations necessary to run the organization effectively, in compliance with legal and regulatory requirements.

Sharing and Disclosure

NGTPF does not sell or rent personal information to third parties. Personal information may be shared with:

- Third-Party Service Providers: For services such as payment processing (Stripe, PayPal), data storage (DonorPerfect), and email marketing (Campaign Monitor).
- Legal Authorities: If required by law or necessary to protect NGTPF's legal rights.
- Website Security: In the case of suspected fraudulent or illegal activity.

Data Security

NGTPF employs industry-standard security measures to protect your personal information, including services certified to PCI DSS Level 1, SOC 2 Type II, and ISO 27001 standards. While we strive to ensure the safety of your data, no method of internet transmission can be guaranteed as completely secure. Therefore, any information you share with us is done at your own risk.

In the event of a security breach, NGTPF will take reasonable steps to notify you promptly, which may include electronic communications such as email or a notice on our Website. By using the Website, you agree to receive such electronic notifications. Depending on your jurisdiction, you may also have the right to receive written notification of a breach.

Data collected may be transferred to and processed in the United States or other jurisdictions that may not have equivalent data protection laws.
