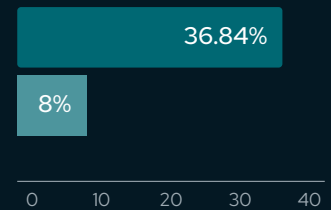

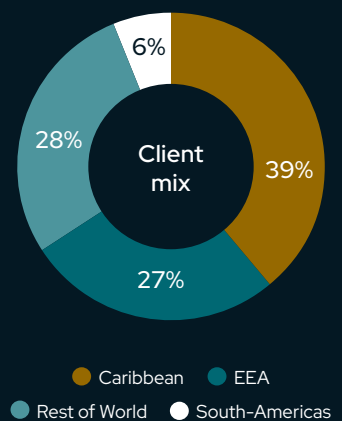
Strong capital ratios
