Disclaimer, Release and Indemnification Agreement

The individual named below (referred to as "I" or "me") desires to participate in one or more singles introduction events, including, but not limited to, proprietary modified speed dating (each an "Event"), being held from time to time by Singles Connections Group, LLC, a New York limited liability company ("SCG"). In consideration of being permitted by SCG to participate in the Events and in recognition of SCG's reliance hereon, I agree to all the terms and conditions set forth in this agreement (this "Release"). I understand and agree that this Release applies to any future Events that I attend, and that my failure to sign a new Release at a future Event does not affect the ongoing validity and effectiveness of this Release.

No Criminal Background or Identity Verification Checks; No Representations

I understand that SCG does not conduct criminal background or identity verification checks on participants in the Events ("Participants") or otherwise inquire into their background. I further understand that SCG makes no representation or warranty as to, and does not assume any responsibility for, the conduct, compatibility, identity, intentions, or legitimacy of Participants or with respect to the accuracy or truthfulness of any information a Participant may disclose to me. **I acknowledge that there are risks involved with meeting people with whom I am not familiar and that my participating in the Events and meeting with Participants is voluntary, at my own discretion, and at my sole risk. I agree that I will use my best judgment when interacting with other Participants.**

Waiver and Release

I hereby expressly waive and release any and all claims, now or hereafter known, against SCG and its officers, managers, employees, agents, and members and their respective heirs, representatives, successors, and assigns (collectively, "Releasees"), directly or indirectly arising out of or attributable to my participation in the Events, whether arising out of the ordinary negligence of SCG or any other Releasees or otherwise ("Claims"). This waiver and release includes, without limitation, Claims on account of any injury, death, damage (including property damage and damage to my reputation), liabilities, losses, costs, or expenses that I may suffer or incur. I agree not to make or bring any Claim against SCG or any other Releasee, and forever release and discharge SCG and all other Releasees from liability under any Claims.

My Indemnification of SCG

I will defend, indemnify, and hold harmless SCG and the other Releasees against any and all losses, damages, liabilities, claims, actions, judgments, settlements, awards, penalties, fines, costs, or expenses of whatever kind, including reasonable attorney fees, incurred by or awarded against SCG or any other Releasee arising out of or resulting from any claim of a third party directly or indirectly related to my participation in the Events.

Additional Terms

This Release sets forth the sole and entire agreement between SCG and me with respect to the subject matter of this Release and supersedes all prior and contemporaneous understandings, agreements, representations, and warranties, both written and oral, with respect to such subject matter. If any provision of this Release is invalid, illegal, or unenforceable in any jurisdiction, such invalidity, illegality, or unenforceability shall not affect any other provision of this Release or invalidate or render unenforceable such provision in any other jurisdiction. This Release is binding on and shall inure to the benefit of SCG and me and each party's heirs, representatives, successors and assigns. All matters arising out of or relating to this Release will be governed by and construed in accordance with the laws of the State of New York. Any claim or cause of action arising under this Release may be brought only in the state courts located in Nassau County, New York and I hereby consent to the exclusive jurisdiction of such courts. The information provided by me below is accurate as of the date set forth below. If any of such information changes before my attendance at an Event, I will inform SCG at or prior to such Event of my current information.

By signing below, I acknowledge that I have read and fully understood this Release, that I understand and, in consideration for my being permitted to participate in Events, I agree to its contents, including my voluntarily giving up of substantial legal rights, including the right to sue SCG and the other Releasees as set forth above.
