Disaster response and recovery - Following hurricanes, flooding, and wind events, NECHAMA provides responsive services by mucking out homes; removing debris, damaged goods, and mud and sediment; gutting homes down to their studs to prepare them for rebuilding; and clearing downed trees, brush and dislodged debris.

Disaster preparedness - In an effort to help affected communities and national and local partners, NECHAMA offers preparedness training aimed at improving the disaster response skills of local volunteers and staff.

Combating Antisemitism - Motivated by the Jewish value of Tikkun Olam (the obligation to repair the world), NECHAMA provides disaster relief services to the most vulnerable members of their impacted communities regardless of religion. Many served by Nechama have never previously met a Jewish person. NECHAMA engages in community relations to help humanize Jews and combat antisemitism.

Reasonable Cause for Late Filing

Statement 1

The Organization respectfully requests abatement of any penalties associated with the filing of its Form 990 because the Organization exercised ordinary business care and prudence in attempting to comply with its filing obligations. The Organization engaged a qualified tax professional to prepare and file Form 8868, Application for Extension of Time To File an Exempt Organization Return, on its behalf. The Organization relied in good faith on its accountant's expertise and took reasonable steps to ensure that the extension was timely filed.

Prior to the original due date of the return, the accountant timely submitted Form 8868 electronically. The electronic filing was subsequently rejected due to a transmission or processing issue. The last electronic transmission attempt occurred on May 15, 2026. Upon learning of the rejection, the accountant promptly took corrective action and submitted a paper Form 8868 on May 20, 2026. An IRS Notice CP211C was sent indicating the the extension was denied. IRS Modernized e-File (MeF) procedures recognize a perfection period following a rejected electronic filing during which corrective action may be taken. The paper-filed extension was submitted within the applicable period following the electronic rejection, and therefore the Organization reasonably believed that its extension request had been timely perfected and accepted.

At all times, the Organization acted diligently and in good faith. It retained a qualified tax professional, provided the information necessary to complete the filing, and reasonably relied on that professional to satisfy the applicable filing requirements. The Organization had no reason to believe that the extension request had not been properly and timely filed.

Any late filing was not the result of willful neglect, intentional disregard of the rules, or a failure to exercise ordinary business care. Rather, it resulted from an electronic filing rejection and the subsequent efforts to perfect the filing in accordance with IRS procedures. Upon becoming aware of the issue, corrective action was taken promptly. Accordingly, the Organization respectfully requests that the IRS recognize that reasonable cause existed for any delay, that the extension be treated as timely filed, and that any penalties assessed be fully abated pursuant to the reasonable cause standards set forth in Treasury Regulation 301.6651-1(c) and applicable penalty-relief provisions.
