Tuition per student = \$8,400

Multi-Child Discount Policy

- **1st child:** Full tuition
- **2nd child:** 15% discount
- **3rd child:** 20% discount
- **4th child and beyond:** 25% discount

Staff Discount: 50% tuition discount

Multi-Child Discount: The first child is charged full tuition. Discounts apply to additional children only as follows: 2nd child 15%, 3rd child 20%, and 4th child and beyond 25%. Discounts may not be combined.

Financial Aid

Financial assistance is available through **FACTS Grant & Aid** and awarded based on household income and assets. Financial aid is awarded only to registered families. Families receiving Good Shepherd Catholic School financial aid are expected to provide additional service support.

TEFA Notice: Tuition assistance may be adjusted if a family receives funding through a **Texas Education Freedom Account**.

Important Reminder for Current Families

All tuition payments for the **2025–2026 school year must be paid in full by June 19, 2026** in order to remain in good standing for re-enrollment.
