Application criteria, fees and scholarships

Birkbeck Bengaluru welcomes applications from ambitious students who are ready to build globally relevant skills and pursue international career opportunities. Entry requirements are designed to identify students with the academic capability, curiosity and motivation to succeed in a rigorous, globally benchmarked degree.

Applicants will typically be required to demonstrate prior academic achievement and submit supporting documentation as part of the application process. Required documents include academic transcripts, proof of English language proficiency identification documents and other relevant supporting information. Full details of the specific documents required for each degree will be provided during the application process.
