The main applicant can include their spouse, unmarried children under 30, and parents over 55 as dependants in one application.



## DUAL CITIZENSHIP

Citizens of São Tomé and Príncipe are allowed to have dual citizenship.



## NO RESIDENCE REQUIREMENTS

Applicants do not need to visit or live in São Tomé and Príncipe to obtain or keep their citizenship.



## COMMUNITY OF PORTUGUESE LANGUAGE COUNTRIES (CPLP)

Citizens of São Tomé and Príncipe have special privileges in CPLP member states, which include Portugal and Brazil.



## AFFORDABLE LIFESTYLE

Enjoy a relaxed island lifestyle with a low cost of living and natural beauty.

## Applicant Requirements

- Applicants must be at least 18 years old.
- Applicants must pass due diligence to apply for the programme.
- Applicants must not have a criminal record.
- Applicants must show proof of a valid source of income.
- Applicants must be in good health.





## PROGRAMME OPTION

Citizenship by investment in São Tomé & Príncipe is available through a qualifying contribution to the National Transformation Fund. To qualify for economic citizenship by investment, applicants have the following option:

### National Transformation Fund

Upon payment of a non-refundable submission fee of USD 5,000, the application is formally submitted to the Citizenship Unit.

Investment thresholds are as follows:

- USD 90,000 for a single applicant
- USD 95,000 for a family of two to four
- USD 5,000 for each additional dependant

This programme offers a straightforward and valuable way to gain citizenship for individuals and families who want to support the long-term development of São Tomé & Príncipe. Contributions go toward important areas like renewable energy, infrastructure, education, affordable housing, tourism, and eco-tourism, helping to drive sustainable economic and social progress across the nation.
