Off Premise Beverage Services

Tidewater Catering Group holds a full liquor license with the State of New Hampshire. Bartenders are billed at an hourly rate based on the style of bar service requested. A minimum of three hours will be billed. Please note that bars may not be longer than five hours in length. We require one bartender per 75–100 guests depending on service level requested.

Host Bar

\$58.00 per hour, per bartender (1 bartender per 80–100 guests), minimum \$174.00 billed

All alcohol provided and dispensed by Tidewater Catering Group. No alcohol may be provided or consumed from outside parties.

24% service charge and 8.5% meals tax will be added to client bill.

Host bar bills the client on consumption per drink.

Wine By the Glass (\$12.00 – Sangrovese, Sauvignon Blanc, or similar)
(Pinot Grigio, Chardonnay, Cabernet Sauvignon, or similar)

Assorted Beers (\$6.00 – 4 selections: imported or domestic)

High Noon Spiked Seltzer or Downeast Cider (\$7.00)

Soft Drinks/Bottled Waters (\$2.00)

Mixed Drinks (One Liquor) Call Brands (\$11.00) (Premium (\$12–\$15.00))

Note: Premium wines and premium micro brew selections are available upon request (selections vary: priced accordingly by the glass or each)

Cash Bar

\$68.00 per hour, per bartender (1 bartender per 75 guests), minimum \$204.00 billed

(Cash bars will only be provided for groups of 50 guests or more)

All alcohol provided and dispensed by Tidewater Catering Group.

Minimum of \$400.00 cash bar sales required or balance charged to client.

Cash bar bills the customer individually for the drink, including tax of 8.5%.

No alcohol may be provided or consumed from outside parties.

Our bartenders will also be permitted to accept cash tips from guests.

We are able to accept cash or credit cards at our cash bars.

Additional Note: Please be advised that additional charges for travel time, mileage reimbursement, set up/breakdown time, and cost for supplies (ice, buckets, etc. . . .) may apply.

State of NH Liquor License Laws:

The sale and service of all alcohol is strictly regulated by the State of New Hampshire. As a licensee, Tidewater Catering Group is responsible for the administration of these regulations.

- Tidewater reserves the right to close a bar if liquor laws or Tidewater policies are violated. Additionally, we reserve the right to discontinue bar service entirely should patrons be unwilling to abide by our administration of liquor licensing laws.
- Last drink is served no later than 15 minutes before the end of service.
- We have a zero tolerance for minors consuming alcohol. Minors are the responsibility of the client signing the Event Order agreement.

Tidewater Catering Group's managers, bartenders and servers are trained in responsible beverage service and if necessary will refuse service to anyone that, in their opinion, appears to be consuming more alcohol than is considered responsible and safe. **We ask that you support us in meeting this responsibility.**

- In some cases, extensive paperwork is required to be files with NH Liquor Enforcement. This may result in a \$100 filing fee.
