Sound measured 20 ft behind exhaust, rev halfway to tach redline, max of 104 dBA^		
No structural rust near suspension points		

* We highly recommend that the items marked with an asterisk (*) should be checked before every session.

** For all convertibles, the driver with helmet on, sitting up straight, must be 1 inch below roll bar. Roll bar or cage must be current with its certification.

^ Sound testing must be completed once per year and each time exhaust is modified.
