Always consult with an association representative/lawyer before responding to any report, letter, memo and/or questions concerning an investigation that could possibly lead to punitive action. If ordered to do so, ask to have it recorded and read the following: Non-waiver statement:

"I have been refused the right to have a representative of my choice. I understand that I am being ordered to make a report or answer questions and that, if I do not comply with the order, I may be disciplined for insubordination.

Therefore, I have no alternative but to abide by the order. However, by so doing, I do not waive my constitutional rights to remain silent under the 5th and 14th amendments to the United States Constitution and under the protections afforded me under state law."



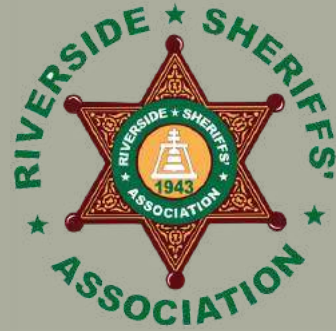

2023 Legislative Scorecard

Well, it's

that time of year, when we release our legislative scorecard grading Riverside-area members of the state Assembly and Senate on their public safety and law enforcement voting record.

It's always difficult to condense an entire year's worth of public safety votes into a single article and scorecard. Many of the significant bills from this year are omitted here because they failed to be voted on in both houses of the legislature. Some failed passage out of committee or were defeated on the floor before they could advance to the opposite house. Others advanced but were later defeated in the committee or the author pulled the bill due to lack of votes.

RSA's legislative efforts, in conjunction with the other major law enforcement associations, were successful in defeating or significantly amending many of the most egregious senate and assembly bills this year. Legislation to eviscerate the Peace Officers' Bill of Rights, prohibit "consent" searches, eliminate police canines and defund school resource officers were among those killed earlier this year. However, because those bills and others did not survive to receive a vote in both the Assembly and Senate, they are not included in this scorecard.

SCORING ADJUSTMENTS

Adjusted voting scores, indicated by an asterisk* or two** were implemented to take into consideration lawmakers stated position on how they planned to vote on a bill. During the



last few weeks of session, lobbyists are constantly verifying where individual legislators are at on bills that are expected to have a close vote. When we can show that a bill lacks support from a majority of legislators, that bill is frequently never brought up for a vote. For our scorecard, we wanted to make sure that those who committed to support the position of RSA were credited for those positions, which helped to prevent those bills from being brought up for a vote.

Relatedly, those who refuse to share how they plan to vote on the floor requires us to place them in the "opposition" column for vote counting purposes. Legislators who routinely refuse to share where they are at on a bill generally do so in order to avoid upsetting one side or the other or in hopes that the bill will never be brought up for a vote, allowing the lawmaker to claim to either side (or both) that they would have voted a certain way.

Our last scoring adjustment is in recognition of the presumption that legislators vote in favor of bills that they have co-authored, even if the bills has not been brought before them for a vote. This year, Asm Corey Jackson co-authored three bills on our scorecard (SB 50, 58 & 94) but he never had an opportunity to vote on SB 50 or SB 94. Removing those bills from his scorecard vote would mislead readers into believing that his position on these bills is unclear.

GUBERNATORIAL ACTIONS

Of the eight scorecard bills that ended up on the governor's desk, four opposed by RSA were vetoed and one was signed that we supported. Just three of the seven bills opposed by RSA were signed into law.

AB 280	limits and prohibits use of solitary confinement, even to protect inmates or staff
AB 733	bans officers from purchasing their own service firearm from employer
AB 958	inmates get “right” to have visitors, regardless of their current, violent behavior
AB 994	requires law enforcement agencies to provide known, false info about suspects to the public
AB 1028	protects violent abusers, removes mandate that medical staff report domestic violence
AB 1034	permanent ban on using police body-worn cam video with facial recognition technology
AB 1310	allows early release of felons convicted of using firearms in their violent crimes
AB 1463	severely restricts law enforcement’s use of license plate reader data to solve crimes
AB 1486	LEAs can’t purchase/use tactical rifles without prior public hearing and vote by elected officials
AB 1584	violent offenders claiming temporary mental incompetence can avoid prosecution & punishment
AB 1726	past convictions of loitering for prostitution deemed legally invalid
SB 2	bans ccw holders (and 1,000s of off-duty peace officers) from carrying in most public places

SB 519	creates another duplicative & politically-charged jail oversight body
SB 623	extends law enforcement’s current PTSD workers’ comp presumption to 1/1/2029



Of the 19 bills on this scorecard, 12 failed to secure final passage in 2023. As a result, we will need to continue to battle these bills next year, along with the other “two-year bills” (including the canine bill, etc) as well as all of the new anti-public safety bills that this legislature is expected to introduce when they return to the Capitol in January, 2024. Until next month, be safe. ★
