CHANGES TO THE BOARD OF DIRECTORS

In July of each year, the nomination and election cycle for Directors and Officers, President, Secretary, and even numbered Chapter Directors during even numbered years, Vice President, Treasurer, and odd numbered Chapter Directors in odd numbered years, begins. During

this time, candidates who meet the minimum qualifications are required to submit their interest and obtain the appropriate number of signatures for the desired position. If a candidate meets the requirements, submits the appropriate paperwork, and no one else submits the proper paperwork, the sole candidate will be selected for the position without a vote. If multiple candidates meet the requirements, an

President, her current Secretary term will be vacated midterm. Per the RSA Bylaws, the RSA Board of Directors voted to fill the vacated spot/term with a Member of the Board of Directors. election shall be held during October and November of the same year. If no one applies for a position, per the RSA Bylaws, the President shall appoint to fill the vacancy.

In July of this year, RSA Treasurer Mike Hyland ran unopposed, and therefore he will be re-appointed to his position. Similarly, RSA Secretary Alicia Lopez ran unopposed for the office of Vice President and therefore will be appointed Vice President of RSA. I want to congratulate Alicia and Mike on their appointments and look forward to serving with them in the coming year.

PURCHASE OF NEW RSA TOW VEHICLE

To expand RSA's ability to support our Membership, the RSA Board of Directors approved using one-time left-over money from the 2020 RSA operating Budget to purchase an additional cargo trailer to support our large Membership, our BBQ Trailer, and help support RSA staff during the Sheriff's Picnic and other functions. When we took possession of the trailer, it was determined an additional tow vehicle was needed to help ensure safety, smooth operation and allow us to be self-sufficient. The



issue was brought to your Board of Directors. After much research and several hours of discussion during multiple board meetings, your Board of Directors approved using one-time left-over money from the 2021 RSA operating budget to secure and start the build of a new tow vehicle - F450 or similar with a commercial bed -

these events are planned to resume in 2022, and therefore those annual dollar allocations will be spent on those events. If you have additional questions regarding the purchase, please reach out to your Chapter Director or me, and we will try to provide you with an answer.

NATIONAL LEGISLATION

President Biden signed three pieces of bipartisan legislation into law in support of police officers. The president signed into law S. 1511, the "Protecting America's First Responders Act of 2021," S. 1502, the "Confidentiality Opportunities for Peer Support Counseling Act or the COPS Counseling Act," and S. 921, the "Jaime Zapata and Victor Avila Federal Officers and Employees Protection Act.

The "Protecting America's First Responders Act of 2021 will better ensure that law enforcement and first responders who are disabled in the line of duty have prompt access to benefits.

The "Confidentiality Opportunities for Peer Support Counseling Act" or the "COPS Counseling Act" sets requirements for peer support counseling programs to be provided by a law enforcement agency. The legislation also encourages first responder agencies to adopt peer counseling programs by requiring the DOJ to make best practices publicly available on its website and to provide a list of training programs for individuals to become peer support mentors.

The "Jaime Zapata and Victor Avila Federal Officers and Employees Protection Act" ensures that individuals who have killed or attempted to kill U.S. federal officers and employees serving abroad can be brought to justice and prosecuted in the United States.

As always, stay safe out there and help ensure your partners go home safe. ★

Riverside Sheriffs' Association Scorecard Bills 2021

Most of the bills listed on the 2021 scorecard were voted on by the entire Senate and Assembly. Some of the bills, however, did not receive a final floor vote in one of the houses. However, because we strongly opposed these bills, we included the votes that were cast. A blank space indicates that a legislator did not have an opportunity to vote on the bill, lowers the total number of bills and results in an adjusted percentage consistent with the positions taken by the Riverside Sheriffs' Association.

AB 48 – limits tear gas, pepper spray, rubber bullets, etc by police for crowd control.

AB 124 – inmates under 26 who claim trauma to get the lowest available term.

AB 333 - limits future gang enhancements and applies retroactively.

AB 481 – limits law enforcement agencies from acquiring surplus military equipment.

AB 490 – prohibits control holds that may result in “positional asphyxia.”

AB 937 - “sanctuary state” protections extended for violent felons.

AB 990 - creates a new “right” for state and local prisoners to meet with visitors.

SB 2 - licensing and de-certification process for peace officers.

SB 81 – defendant past trauma used to dismiss sentence enhancements.

SB 98 – reporters granted right to secured areas during civil protests.

SB 262 - another effort to abolish cash bail for criminals.

SB 284 - expands PTSD presumptions to additional groups of peace officers.

SB 299 - allows felons to receive victims comp assistance if injured by police.

SB 357 - eliminates crime of loitering for purposes of prostitution.

SB 519 - decriminalizes ketamine, ecstasy, mushrooms, LSD, mescaline, peyote, etc.

SB 710 - seeks to prevent POAs/DSAs from contributing to DA campaigns.

SB 731 - allows all felons to have their record expunged.

SB 775 - re-sentencing for voluntary manslaughter/attempted murder conviction. ★

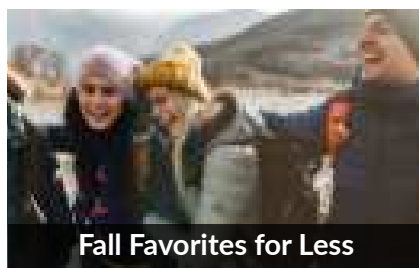

On September 12, 2021, Timber was taken to California Veterinary Specialist in Murrieta where he underwent an unforeseen emergency procedure and pulled through it. Unfortunately, I was shocked to learn he was diagnosed with cancer. Timber returned home the next day and recuperated.

Timber bounced back quickly and returned to his happy self for about four weeks. Unfortunately, his health began to decline again and rapidly. In honor and respect of Timber and to preserve his happiness, dignity, and remaining health, I made the very difficult decision to have him put to sleep.

The day before his passing, we enjoyed a family campfire and my family gave him lots of attention. The next morning I made him some bacon, we watched the sunrise on the porch and I took him for his last walk. Later, my wife and kids said goodbye to Timber for the last time. I put him in the back seat of my truck and he greatly enjoyed his last ride as he barked proudly at the passing cars and people.

We took the long way, but inevitably arrived at the Animal Medical Center in San Jacinto. The veterinary staff at AMC had been caring for Timber since the start. On October 25, 2021, at 1110 hours, Timber passed away peacefully in my arms. It broke my heart to say goodbye and I will never forget him. Timber was courageous and kind. He was my partner, my protector, my best friend and a huge part of our family and my life.

IMMUNITY AFTER RECOVERING FROM COVID-19?

On October 22, 2021, a judge in Kern County determined that the power of the State is such that it can mandate vaccinations for certain employees. The judge stated that the Court was

not in a position to dictate which and when such steps should be addressed by the State to deal with the COVID-19 pandemic. This finding is similar to litigation in other states enforcing the vaccination mandate through either executive order or legislation to control the spread of COVID-19. There are some limited exceptions based on

religious perspectives and beliefs. The rationale for government-mandated vaccinations is based upon the attempt of the government to control the spread of the pandemic, and does not reflect the potential immunity obtained by some individuals who have been infected with COVID-19 and subsequently recovered. Therefore, having had COVID-19 could potentially be viewed as a vaccination.

The argument being made against vaccination mandates is that they violate meet-and-confer collective bargaining between unions and employers. In many situations, however, the courts have responded by finding that such mandates adhere to the power vested in the Federal Government and states to control the spread of disease. State interests in maintaining public health empower employers, the state, cities and other municipalities to mandate vaccinations, and failure to do so can be a basis for termination. Again, mandating vaccinations does not reflect an aspect of immunity which can be in a worker's system from having experienced COVID-19 and

recovered from it – a medical change which, in essence, may constitute a COVID-19 vaccination.

A recent study by the University of Pennsylvania acknowledges that there are ways to control the advancement of COVID-19. The first way is through vaccination. The second way discussed is that people who have acquired a sufficient level of immunity to infection can limit the advancement of the coronavirus. This concept of a community level of immunity through infection is one that is being looked at and may not mandate vaccination. Each individual has a different response to COVID-19 exposure, but of particular

to embrace the concept of a blanket mandate to vaccinate everyone.

Of note, the antibody levels in both vaccinated individuals and people who have recovered from COVID-19 infections drop over a period of time, resulting in reduced immunity in both groups.

In a study done by Rockefeller University on August 24, 2021, it was discovered that individuals who have previously contracted COVID-19 show a more potent antibody response than those who were solely vaccinated for the virus. Previously-infected COVID patients appeared to develop memory D cells which produce more potent antibodies than memory cells

In August 2021, Dr. Michel Nussenzweig at Rockefeller University recommended that even individuals who have recovered from COVID-19 should be vaccinated, because the combination of vaccination and prior infection produces the highest level of protection.

Dr. Michael Osterholm, Director of the Center for Infectious Disease Research and Policy at the University of Minnesota, has stated that he believes the level of protection from previous infections over time will not be accepted as immunity. However, the science of immunity without vaccinations is ever evolving and will change as more information is developed.

Research has further shown that recovered COVID-19 patients possess neutralizing antibodies up to a year after infection, and such infection assists in offering protection against developing variants.

significance is the recognition that individuals who have not been vaccinated indeed can develop immunity to the occurrence of COVID-19. While studies indicate that this group can benefit from being vaccinated, the findings reveal that individuals who have this immunity have a much lesser likelihood of reacquiring the virus even without a vaccination.

Another level of analysis suggests that some workers who recover from COVID-19 still need to be vaccinated. The approach of local governments, counties, cities, states and the Federal Government has been

developed through vaccination.

Research has further shown that recovered COVID-19 patients possess neutralizing antibodies up to a year after infection, and such infection assists in offering protection against developing variants. The study states: “Both groups retained the ability to neutralize all the variants of the coronavirus, but those previously infected displayed overall better neutralization capacity.”

The Chief Medical Adviser for the President acknowledges we are learning more about postinfection immunity, but nevertheless recommends vaccinations.

Cornell Law School uses the term “vaccine” to mean “any substance designed to be administered to a human being for prevention of one or more diseases” (26 U.S. Code 4132).

At this time, differences of opinion clearly exist as to the individual situations for people who have been vaccinated and those who have not been vaccinated but have been infected by coronavirus and recovered from the disease with some degree of immunity. This conflict is good in that it creates knowledge regarding both the benefit of the vaccine for those who have been vaccinated, and the benefit of having



experienced COVID-19 for many who have been infected and recovered.

While medical studies reflect that the vaccination has value, there needs to be further understanding as to both pre-existing immunity and subsequent immunity for COVID-19 survivors. Existing studies clearly indicate that

coronavirus survivors do have some degree of immunity. The question then becomes: What are the differences for those who have been vaccinated and those who have been infected by COVID-19 and recovered?

It would appear that the courts, in embracing vaccination mandates,

should seek further information as to the immunity which does exist for COVID-19 survivors. How similar is their protection to being vaccinated? Is it similar to the extent that they can be held exempt from vaccination mandates? Hopefully, the future will soon provide these answers. ★
