HC junks plea seeking CBI probe into Adani Green bribery claims

THE BOMBAY High Court on Friday rejected a plea seeking a CBI probe into bribery allegations against Adani Green Energy Ltd and its associates to secure solar power contracts across several states. It sought directions to the CBI to register an FIR under the Prevention of Corruption Act.

A division bench of Chief Justice Shree Chandrashekar and Justice Suman Singh dismissed a plea by 61-year-old Jitendra Maru from Silvassa, who relied on proceedings of a US criminal indictment and a parallel Securities and Exchange Commission (SEC) case, presently pending before a court in

New York's Eastern District in the US.

The plea claimed there was an organised bribery scheme by Adani Green Energy and a Delhi-based renewable energy firm, Azare Global, which consisted of an agreement to pay Rs. 2,000 crore bribe to officials of state power distribution companies (discoms) in Andhra Pradesh, Tamil Nadu, Maharashtra, Odisha, Chhattisgarh and Jammu and Kashmir to ensure they entered into agreements that inflated tariffs and purchased more solar power.

Maru claimed the payments concerned were mentioned in "bribes" and electronic records allegedly maintained by an Adani Green Energy executive director and seized by the US

Federal Bureau of Investigation (FBI) and reproduced in proceedings before US courts. Maru sought directions to the CBI to obtain all the texts of the "Bribe Notes and Electronic Data and Records" seized by US probing authorities.

The HC, while dismissing the plea observed the petitioner "failed to establish his bona fide" and had "no locus (legal standing) to file the same. The Court said the plea is "likely to cause harm to the reputation and business prospects of any corporate group".

No CBI probe against RIL: High Court

The HC also dismissed another plea by Maru seeking a criminal investigation by the

CBI into allegations that Reliance Industries Limited (RIL) unlawfully extracted natural gas from the Oil and Natural Gas Corporation's (ONGC) Krishna-Godavari (KG) Basin fields.

Maru sought registration of an FIR for alleged offences of theft, misappropriation and criminal breach of trust, among others.

He had alleged that RIL drilled deep-sea wells between 2004 and 2013-14 that enabled gas from the adjoining ONGC blocks to migrate to RIL's KG-D6 block. Maru, claiming the process to be "massive organised fraud," sought registration of an FIR and also sought directions to the CBI to seize the contracts, data related to drilling and government reports.

5 women, 3 kids die as pickup truck rams into trailer in UP

Kaushambi: A pickup truck carrying devotees rammed into a stationary trailer truck on a national highway in Kaushambi district on Friday, killing five women and three children, police said. The accident took place near Doroma petrol pump under the Saini station area around 4 km from the pickup vehicle en route to Fatehpur from Prayagraj, crashed into a trailer parked on the roadside, police said. HC dismisses Amritpal plea to attend Parliament session

THE PUNJAB and Haryana High Court on Friday dismissed Khador Sahib MP Amritpal Singh's plea seeking temporary release to attend the budget session of Parliament while under preventive detention under Section 15 of the National Security Act (NSA), 1980.

Amritpal, lodged in Assam's Dibrugarh jail under the NSA since April 2023, had challenged a Punjab government's February 2, 2026 order refusing

to grant him parole to attend the Parliament session.

A Division Bench comprising Chief Justice Sheel Nagu and Justice Sanjay Berry upheld the impugned order, observing that "national interests are paramount when compared with personal interests".

In its February 2 order, the Punjab government had declined Amritpal's application for temporary release to attend the budget session of Parliament, citing "serious threat to the security of the state and the maintenance of public order".

Chakankar quits as chief of NCP women's wing amid Kharat row

IN A SWIFT political fallout from the widening Ashok Kharat scandal, NCP leader Rupali Chakankar on Friday night resigned as the party's women's wing chief just a week after stepping down as chairperson of the Maharashtra State Women's Commission.

The back-to-back exits underscore the mounting pressure on Chakankar following Kharat's arrest in Nashik on charges of sexual assault and rape, and the emergence of photographs showing her proximity to the self-styled godman. The controversy had already drawn intervention from CM Devendra Fadnis, who had directed her to resign from her post last week.

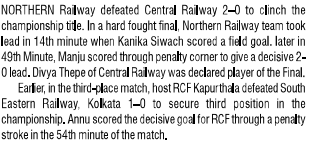
BKSBD's International School Celebrates Graduation Day
