1. Introduction

Persistent cookies - remain on Your device until they expire or are manually deleted.

First-party cookies - set by the website You are visiting.

Third-party cookies - set by external services or parties.

3. Types of Cookies

Our Company uses only Strictly Necessary Cookies (Security) on the Website. These cookies are essential for the proper functioning, security, and basic operation of the Website. They enable core features such as User authentication, session management, access to secure areas, and protection against fraudulent activity. Strictly necessary cookies are set automatically and do not require User consent, as without them the Website cannot function properly. The cookies we use do not collect data that reveal Your personal identity and therefore do not make it possible for us to identify you.

The Website does not use cookies for analytics, advertising, profiling or marketing purposes.
