1. Hood replacement in labs (better ventilation) - \$101,424.30
2. Compensation for Graduate Assistants to assist with teaching courses - \$1,866,160.98
3. Salary and benefits for Student Affairs staff performing non-administrative duties:
  - a. Salary - \$744,056.95
  - b. Benefits (49% federally approved rate) - \$364,588.12
4. Facilities and administrative (indirect cost) at federal negotiated rate of 45% on all expenses except for tuition (and lost revenue) - \$754,34.79

NOTE: Due to an issue with how we recorded the lost revenue during CY21, there was a reduction in the F&A recorded during this quarter. The amount of the reduction was \$614,376.
