On Monday, October 31, 2022, pursuant to SGA Supreme Court matter, "Aaron J. Jordan vs. Senator Oscar Martinez," Case# 122-2, the SGA Supreme Court decided to censure SGA Senator Oscar Martinez, instead of impeaching and removing the senator. However, the SGA Constitution is silent on matters of censuring SGA officers and officials. During the subject ruling in the cited matter, the Chief Justice stated various provisions that a censure would include, such as a written letter being placed in Senator Martinez's SGA file and a mandatory meeting with the SGA staff advisors. However, none of these provisions are included or outlined in the SGA Constitution. Therefore, in the cited matter, the SGA Supreme Court has enacted a ruling that is currently not codified in the SGA Constitution.


