Additional fee information

Below we set out the hourly rates for private fees as well as the government funded extra costs.

We include in our fees shown above, so that no calculation is required from you. A full explanation can be found on overleaf.

	Key terms
Attendance	2,3,4,5 full days or 5 half days - Days must be consecutive, including a Monday or Friday.
Holidays/ closure days	All bank holidays, closure days and training days are paid days, with no exceptions or rearrangements.
Ad-hoc sessions	Additional sessions are bookable at a premium of £5 on the daily rate, if we have availability. These are non-cancellable, bookable 24 hours in advance and must be paid in advance.
Acceptance of a place	Once you have accepted a place, it becomes yours, with the paperwork being completed as requested.. We require full contractual notice if you change your mind after accepting a place.
Changes to a booking plan	You must provide one month's notice for any requests to decrease hours including a withdrawal. These changes will be implemented only at the beginning/end of a month. <i>For example, you give notice on 15th January - Changes effective from 1 March.</i> For requests to increase hours, we will look to do this as soon as availability allows.
Government funding Additional information	It is not possible to provide our service without charging for the extras we provide. These are charged per 15 hours per month and are currently as below for 3/4 year olds: Meals (Breakfast, 2x Snack, Lunch, Tea) - £66 Consumables (nappies, wipes, suncream) - £40 Additional lessons - £27 All extra charges are calculated on based on the hours, annualised and are billed as part of our monthly fees shown on page 1. On invoices, we will itemise these in three rows. We do not charge extras for 9 month olds and reduce extra costs for those in receipt of 2 year old funding. We do this due to the superior funding we receive for younger children of that age. Total extras included for 3years+ children per month: £133 for use of 15 hours £266 for use of 30 hours Total extra cost for 2 year olds per month with funding: £47.50 for use of 30 hours If you have a private contract, and wish to opt-out of these charges, we will require notice to be given in line with changes. We continually monitor occupancy to understand which booking plan we can offer as "funded-only" places, so availability will change each month. It is not possible to switch private hours to funded-only, as we offer different contracts for these. Funded-only places must be re-applied for each term as availability will vary with the availability at the time.
