

Arbor Acres Application for Education Support



This application will review your eligibility for current education programs at Arbor Acres.

Arbor Acres Artists: IF YOU ARE PRN, YOU ARE NOT ELIGIBLE FOR EDUCATION ASSISTANCE AT THIS TIME.

Please feel free to complete this application when you are a regularly scheduled part-time or full-time employee and have completed at least 6 months of full or part-time employment.

WHICH PROGRAMS MIGHT YOU BE ELIGIBLE FOR:

- Arbor Acres Resident Educational Scholarship (including non-job related)
- Arbor Acres Tuition Reimbursement (if Resident Scholarship doesn't cover all costs.)

Eligibility for both programs: FT or PT (regularly scheduled) for at least 6 months, and no disciplinary actions (1 yr.)

Arbor Acres Tuition Reimbursement: Courses must be related to your job or job progression at Arbor Acres AND you must be attending an accredited college or university. Max Award Given: \$500/semester or \$1,000/calendar year.

Resident Scholarship: Arbor Acres Employees only (Fountain Hill Artists are supported through the Rise and Thrive program.) Max Award Given: \$2,500 per semester. This scholarship is funded by resident donations and decisions will be made based on a variety of factors and may not always be available.

WHICH COSTS MIGHT BE COVERED?

Books (online or paper), Tuition (not fees), and Exam fees.

WHICH COSTS ARE NOT COVERED?

Application fees, parking fees and certain other non-tuition expenses are not reimbursable. Any costs reimbursed to you through a separate scholarship or tuition program (no "double dipping").

WHEN WILL I RECEIVE PAYMENT?

Scholarships: You will receive a check made out to the school (in your name), as long as you are approved.

Tuition Reimbursement: You will receive payment IF YOU ARE AN ACTIVE EMPLOYEE and have not given notice of your termination after you provide us proof of attending and passing (A, B, C or "Pass" grade) the courses. **You will have to repay the costs if you leave the organization for a period of one year after the end of your coursework.**

Tuition reimbursement may be considered taxable income; you may want to consult your tax preparer or accountant.
