

CashPeek – Terms & Conditions

Version 1.0 – Effective Date: 06/03/2026

1. Introduction

These Terms & Conditions govern your access to and use of the CashPeek online platform and related services (the Service). The Service is operated by Aglytica Pty Ltd (ABN 71 641 658 611). By creating an account, accessing, or using CashPeek, you agree to be bound by these Terms & Conditions. If you do not agree, you must not use the Service. These Terms & Conditions incorporate and operate alongside the CashPeek Privacy Policy.

2. Licence Grant

Aglytica grants you a non-exclusive, non-transferable, revocable licence to access and use CashPeek for your internal business or personal purposes, subject to these Terms & Conditions and your subscription plan. This is a licence to use the Service — not a transfer of ownership. All intellectual property rights in CashPeek, including software, design, data structures, algorithms, branding, and documentation, are owned by Aglytica or its licensors. Nothing in this EULA transfers ownership of any intellectual property to you.

You may use CashPeek only for lawful purposes and in accordance with this Licence Grant.

You must not:

- Copy, modify, distribute, or create derivative works of the Service.
- Reverse engineer, decompile, or attempt to extract the source code.
- Use the Service in a way that may damage, disable, or impair its operation.
- Use the Service for any unlawful, fraudulent, or harmful activity.

3. Subscription Plans and Billing

CashPeek is provided on a subscription basis. Subscriptions are available on a monthly or annual basis. Fees are payable upfront for the selected period. Your subscription remains active until the end of the paid period. You may cancel at any time through your account settings. No refunds are provided unless required under the Australian Consumer Law (ACL) or where the product is proven unsuitable for your requirements. Aglytica may update pricing from time to time. Changes apply from your next renewal.

4. Cancellation

You may cancel your subscription at any time. After cancellation, you retain access until the end of the current paid period. No further charges apply unless you reactivate. Refunds are only provided where required by law or where the Service is proven unsuitable for your stated needs.

5. Account Registration and Security

To use CashPeek, you must create an account and provide accurate information. You are responsible for maintaining the confidentiality of your login credentials, all activity under your account, and notifying Aglytica of any unauthorised access. Aglytica is not liable for losses arising from your failure to secure your account.

6. Acceptable Use

You must use the Service responsibly. You must not share your login credentials, copy or modify the Service, reverse engineer the software, upload malicious code, interfere with the Service, scrape or harvest data, or engage in unlawful or harmful activity. Aglytica may suspend or terminate access for breaches.

7. Content You Submit

You may upload or enter data into CashPeek. You retain ownership of your data, but grant Aglytica a licence to store, process, and use it to provide the Service. You must ensure your content is accurate, lawful, and does not infringe third-party rights. Aglytica may remove content that breaches these Terms. Aglytica Pty Ltd will handle all data in accordance with its Privacy Policy.

While Aglytica takes reasonable measures to protect data, you acknowledge that no system is completely secure or error-free. You are responsible for maintaining copies of your own data. Aglytica is not responsible for loss or corruption of data except where required by law.

Aglytica may retain your data for a reasonable period following termination to allow account reactivation or data export. After this period, Aglytica may permanently delete the data.

CashPeek is a tool for cashflow budgeting and some simple cost analysis. The information produced by the service is based on data provided by you and should not be considered financial, accounting, or legal advice. You are responsible for verifying all financial outputs.

8. Intellectual Property

All intellectual property in CashPeek — including software, design, data structures, algorithms, branding, and documentation — is owned by Aglytica or its licensors. Nothing in these Terms transfers ownership to you.

9. Service Availability and Updates

Aglytica aims to provide reliable access but does not guarantee uninterrupted service, error-free operation, or that the Service meets your specific requirements. Maintenance, updates, or outages may occur. Updates may be applied automatically.

10. Third-Party Services

CashPeek may integrate with or link to third-party tools. Aglytica is not responsible for their content, availability, or performance. Your use of third-party services is governed by their own terms.

11. Consumer Guarantees and Australian Law

Nothing in these Terms excludes or modifies your rights under the Australian Consumer Law (ACL). Where permitted by law, Aglytica limits its liability for failure to comply with a consumer guarantee to supplying the Service again or paying the cost of having the Service supplied again. This limitation does not apply where it would be unlawful.

12. Limitation of Liability

To the maximum extent permitted by law, Aglytica is not liable for indirect or consequential loss, loss of profits, revenue, or data, business interruption, or damages arising from your use of or inability to use the Service. Total liability is limited to the amount paid by you in the 12 months preceding the claim.

13. Termination

Aglytica may suspend or terminate your access if you breach these Terms, your subscription lapses, you misuse the Service, or Aglytica discontinues the Service. Upon termination, your licence ends immediately.

14. Governing Law

These Terms & Conditions are governed by the laws of Western Australia. You submit to the exclusive jurisdiction of the courts of Western Australia.

15. Changes to These Terms

Aglytica may update these Terms from time to time. Continued use of the Service after changes take effect constitutes acceptance of the updated Terms.
