Directions for Use

For all crops, apply at 16–32 oz (0.5–1 L) per acre per application during periods of abiotic stress. Apply to root zone via fertigation, ensuring soil temperature is above 40°F at time of application. Can be tank-mixed with most fertilizers. Before mixing **SOIL PRO** into the tank, confirm a pH range of 5.5–8.5. If using microbial activator (carbon source), mix at a minimum ratio of 1 oz microbial activator for every 10 oz of **SOIL PRO**.

To prepare the solution, mix water and microbial activator first, then add **SOIL PRO** last.
