**I, LARRY MARGULIES**, being of legal age and competent to make this affidavit, after being duly sworn, state as follows:

**1. Existing investigative submission**

I previously submitted a notarized criminal complaint to the Aventura Police Department concerning Evelyn Yudowitz and Ken W. Shulman. The Department previously confirmed to me by email that the complaint was submitted. I later submitted a notarized Supplemental Sworn Affidavit of Corrections and Clarifications dated August 14, 2026. This further supplemental affidavit concerns the same investigative matter and is intended to be permanently associated with the original complaint and the August 14, 2026 supplemental affidavit.

**2. No replacement or renumbering**

This filing does not replace, withdraw, restart, or refile my original complaint. It does not change the exhibit numbers used in the original complaint. The evidence accompanying this affidavit is intentionally designated as a separate supplemental series, S1 through S7, so that the original exhibit numbering remains unchanged.

**3. Purpose of this further supplement**

After reviewing older publications, third-party marketplace records, and the original October 2020 message screenshots, I organized a narrow chronological evidentiary package concerning the October 5, 2020 Hong Kong SMS evidence. The purpose is to show what subject matter had already been documented before the SMS was received and to request an independent investigative comparison of the earlier material with the later SMS.

**4. Limited purpose of my publications**

Several of the pre-October 2020 publications in S2 through S6 were authored by me. I do not present repetition among my own books as multiple independent witnesses or as independent proof that every underlying event described in those books occurred exactly as alleged. I offer those publications principally to establish prior documentation, chronology, and the fact that particular names, descriptions, and themes were recorded before October 5, 2020.

## **5. Explanation of publication method and preservation purpose**

During the period reflected in these exhibits, I published numerous short electronic books and editions concerning substantially overlapping events, sometimes using different titles, cover artwork, and author-name presentations. Many of these publications were not professionally edited and were assembled quickly. I began publishing in highly improvised circumstances, at times writing on my phone while sitting outdoors or stopping at cafes. I believed that rapid public documentation could help preserve a dated record of what I was reporting and might deter further encounters with persons I feared. When events occurred that I considered significant to the overall matter, I often felt an urgent need to document them rather than delay publication for conventional editing, organization, or production. Accordingly, some works were written and published within a matter of hours and may contain repetition, rough organization, typographical errors, or other editorial deficiencies. My principal purpose was not literary polish or the creation of separate independent accounts; it was to create a publicly dated, persistent record associated with my identity at little or no cost. I provide this explanation so that the number, repetition, differing covers, and editorial condition of these publications are not misunderstood as evidence that they are independent sources. Their relevance in this S-series remains the chronology and prior documentation described elsewhere in this affidavit.

## **6. Marketplace and source records**

Where available, S2 through S6 include records from Kobo, Amazon, or Goodreads reflecting the public listing or publication date of the corresponding work. I offer those third-party records to corroborate the existence and timing of the relevant publication or edition. I do not contend that a retailer or marketplace record proves the truth of the factual allegations contained in a book.

## **7. 2016 evidence in S2**

S2 includes a Kobo record listing a September 8, 2016 release date for the relevant 2016 work, Book ID 1230001337686, together with pages from that work. The selected pages record a person named David at Kukus Nest in Cebu who said he had a Purple Heart and allegedly threatened to tie my feet to cement and drop me into the ocean; separate State Department and hallucinogenic-exposure material; an Escario account involving alleged hallucinogenic effects; and the phrase chemically induced psychosis. I rely on these passages as evidence that the David, government-related, chemical-exposure, and psychosis-related subject matter had been documented years before the October 2020 SMS.

## **8. 2017 evidence in S3**

S3 includes a Kobo marketplace record listing a February 11, 2017 release date, Book ID 1230001542332, selected passages captured from the purchased EPUB, and an S3B source-identification page for that native EPUB. Those passages record a State Department worker and the statement that I was severely psychotic and a criminal; a separate allegation of exposure to a very strong hallucinogen; an attempt to seek a federal law-enforcement officer; and a statement attributed in the book to Gary or Jerry that they have people in the FBI. The latter statement is submitted only as a statement recorded in the 2017 publication, not as proof that any person actually had an FBI connection.

## **9. 2018 evidence in S4**

S4 includes an Amazon record showing an October 9, 2018 publication date for Steve Wilkos and Joe Rogan Help, together with the Kindle title and copyright page, cover, and selected Kindle passages. Those passages include the David and Purple Heart account, a passage stating that certain men strongly implied that they worked with the C.I.A., and a passage combining a severe psychotic characterization with an alleged hallucinogenic exposure. Kindle Location identifiers are used where available because rendered page numbers may vary by reader configuration.

## **10. January 2019 evidence in S5**

S5 includes a Goodreads record showing a January 30, 2019 publication date for Nexistant Inc Equals Child Murder and a Hit Team Behind the Life of Martin Yudowitz, its internal 2019 title and copyright page, and a selected passage recording State Department communications and the statement that I was severely psychotic. This material is offered as another pre-SMS chronology point.

## **11. December 2019 evidence in S6**

S6 includes an Amazon record showing a December 30, 2019 publication date for the Kindle edition of 2020 Bostons Jewish Murder For Hire Plot Public And Families Asked To Help With Arrests and an internal title page stating Published 12 20 2019. I preserve both dates rather than attempting to reconcile them. Both precede October 5, 2020. Selected passages record men who, according to the publication, introduced themselves as CIA and State Department, and again record David at Kukuks Garden Nest in Cebu with the Purple Heart account, a threat involving being thrown over a boat, and an alleged instruction to delete all the phone records. S6 also includes a typed published reproduction of portions of Lesyl Medalla's statement appearing on book pages 9 and 10. The underlying handwritten statement was already submitted to the Aventura Police Department as Exhibit 17A to my original complaint and remains the controlling source document. S6E does not replace or renumber Exhibit 17A and is submitted only to demonstrate the pre-SMS publication chronology and the relationship between the published text and that previously submitted witness material.

## **12. October 5, 2020 SMS evidence in S7**

S7 contains readable reproductions of two preserved image files of the message thread with the Hong Kong telephone number +852 9342 8498. The screenshots visibly identify Monday, October 5, 2020 and show messages containing the terms ELDAVIDE, C.I.A., and SCHIZOPHRENIC. The readable reproductions are not highlighted or cropped. The exact native image files are preserved separately and identified by the SHA256 hash manifest in S7C.

## **13. Investigative comparison requested**

I respectfully request that investigators compare three narrow categories across the pre-SMS material and the later SMS: first, the previously documented name David and the later term ELDAVIDE; second, the previously documented government or intelligence-related representations and the later express C.I.A. reference; and third, the previously documented psychosis or severe-psychotic characterizations and alleged chemical or hallucinogenic-exposure material and the later SCHIZOPHRENIC characterization. I do not contend that any single word

or overlap establishes the identity of the SMS sender. I submit the combination because it is sufficiently specific to warrant independent investigative comparison.

#### **14. No reliance on the phrase trained to deny**

The complete SMS screenshot contains additional language, including a trained to deny statement. I am preserving the complete screenshot, but I do not rely on that phrase as a separate concordance factor and do not ask investigators to draw an inference from it.

#### **15. Requested investigative steps**

I respectfully request that the Aventura Police Department preserve and associate S1 through S7 with the existing complaint record; maintain the S designations as supplemental exhibits without altering the original complaint exhibit numbering; evaluate whether lawful process or interagency coordination can identify or verify the subscriber, account, device, or other records associated with +852 9342 8498; coordinate with the Hong Kong Police Force, the FBI, or another appropriate agency if needed for cross-border records or jurisdiction; and compare any independently obtained telecommunications or account information with the persons and events already identified in the complaint.

#### **16. Authentication and preservation**

If investigators require additional authentication, I request that they consider obtaining or preserving, through appropriate lawful process, available retailer or platform records concerning the publication dates and edition identifiers reflected in S2 through S6 and available telecommunications records concerning S7. I will preserve the source files in my possession and provide additional original-format files or information reasonably requested.

#### **17. Incorporation of exhibit index**

The accompanying Supplemental Evidence Exhibit Index identifies S1 through S7 and their subparts. I incorporate that index by reference solely to identify the materials submitted with this affidavit.

#### **18. Continuing status request**

At the time of my August 14, 2026 supplemental filing, I had not been provided a police case number, incident number, report number, records number, reference number, assigned investigator, or written investigative disposition. If a number has since been assigned, I request that this affidavit and S1 through S7 be associated with that same number. I also respectfully request written acknowledgment of receipt and identification of the current case or reference number and assigned investigative unit or investigator, if available.

### **VERIFICATION**

I declare that I have read the foregoing Further Supplemental Sworn Affidavit and Evidentiary Submission and that the factual statements made from my personal knowledge are true and correct to the best of my present knowledge and recollection. Where I describe the contents of an exhibit, I intend to identify what the exhibit states or shows and not to convert an allegation recorded in that exhibit into independently proven fact.

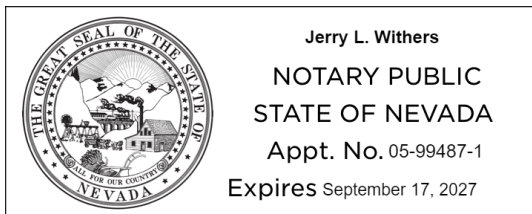

## **S1A - Evidentiary Concordance October 5 2020 SMS**

### **Purpose**

I submit this concordance to identify subjects that I had documented in publications before the October 5, 2020 Hong Kong SMS and to compare those subjects with specific language appearing in the later SMS.

I submit the publications to establish prior documentation and chronology. I do not submit them by themselves as proof that every underlying allegation described in them is true, nor do I contend that the publications by themselves establish the identity of the SMS sender.

### **1. DAVID**

#### **Pre-SMS documentation**

In my 2016 publication, I documented a man named David at Kukus Nest in Cebu who claimed to have received a Purple Heart and who, according to my account, threatened to tie my feet to cement and drop me into the ocean.

In my 2018 publication, I again documented David at Kukuks Nest and the Purple Heart account.

In my December 2019 publication, I again documented David at Kukuks Garden Nest, the Purple Heart account, and an alleged statement concerning deletion of phone records.

#### **October 5, 2020 SMS**

The later SMS contains the expression **ELDAVIDE**.

### **2. GOVERNMENT AND INTELLIGENCE THEME**

#### **Pre-SMS documentation**

In publications issued between 2016 and 2019, I documented State Department, government, security, or intelligence-related representations.

My independently dated 2018 publication contains a passage stating that certain individuals strongly implied that they worked with the CIA.

My December 2019 publication states that men introduced themselves as CIA and State Department.

I submit these passages only to establish what I had already documented before October 5, 2020. I do not contend that those passages, by themselves, establish that any person actually worked for the CIA, State Department, or another government agency.

#### **October 5, 2020 SMS**

The later SMS expressly contains **C I A**.

### **3. MENTAL HEALTH AND CHEMICAL EXPOSURE THEME**

#### **Pre-SMS documentation**

My 2016 publication records my allegation of hallucinogenic exposure and expressly uses the phrase **chemically induced psychosis**.

Later pre-SMS publications again record allegations involving hallucinogenic exposure together with statements or representations that I was psychotic, severely psychotic, or mentally ill.

### **October 5, 2020 SMS**

The later SMS expressly characterizes me as **SCHIZOPHRENIC**.

### **Evidentiary significance**

I do not contend that any single repeated word, name, or subject proves the identity of the sender.

I submit that the combination is significant for investigative comparison because, before the October 5, 2020 SMS existed, I had already documented:

1. a person I knew as David in connection with the Cebu and Purple Heart account;
2. CIA, State Department, or intelligence-related representations; and
3. alleged chemical or hallucinogenic exposure together with mental-health characterizations.

The later SMS then combined the terms or subjects **ELDAVIDE**, **C I A**, and **SCHIZOPHRENIC** in the same communication sequence.

I respectfully request that investigators evaluate that chronology and multi-factor convergence through independent evidence, including any available telecommunications, subscriber, account, device, carrier, forensic, witness, travel, or other records.

## **S1B - Limited Purpose and Source Identification Note**

### **1. Limited evidentiary purpose**

I submit the attached publications primarily to establish chronology and prior documentation.

They demonstrate that particular names, subjects, descriptions, and allegations had been recorded by me before I received the October 5, 2020 SMS.

I do not submit the publications by themselves as proof that every event described in them occurred exactly as alleged.

I also do not submit them by themselves as proof that any identified individual was actually employed by, affiliated with, or acting on behalf of the CIA, FBI, State Department, or any other government agency.

### **2. Self-authored publications**

Several of the publications in this supplemental series were written by me.

I do not present repetition across my own publications as multiple independent witnesses or as multiple independent sources proving the same event.

Their principal relevance here is chronological: they show what I had already documented before the later SMS existed.

### **3. Explanation of my publication method and the number of publications**

During this period, I published numerous short electronic books and editions concerning substantially overlapping events, sometimes using different titles, cover artwork, and author-name presentations.

Many of these publications were not professionally edited and were assembled rapidly.

I began publishing under improvised circumstances, at times writing on my phone while sitting outdoors or while stopping at cafes.

At the time, I believed that rapid public publication could preserve a dated record of what I was reporting and might also deter further encounters with persons I feared.

When events occurred that I considered significant to the overall matter, I often felt an urgent need to document them promptly rather than delay publication for conventional editing, organization, proofreading, or production.

As a result, some of the publications contain repetition, rough organization, typographical errors, inconsistent formatting, or other editorial deficiencies.

My principal purpose was not literary polish and was not to create the appearance of multiple independent accounts.

My purpose was to create a persistent, publicly dated record associated with my identity, using publishing platforms that allowed me to preserve and distribute that record at little or no cost.

I provide this explanation so that the number of publications, repeated subject matter, differing covers, differing titles, author-name variations, and editorial condition of the books are not misunderstood.

#### **4. Independent publication records**

Where available, I include records from Kobo, Amazon, Goodreads, or other third-party marketplace or platform sources showing the existence, listing, publication date, or edition information associated with particular works.

I submit those records to support the chronology and identification of the corresponding publication or edition.

I do not contend that a marketplace listing proves the truth of the factual allegations contained in a book.

#### **5. Original SMS evidence**

Exhibits S7A and S7B are preserved copies of screenshot image files saved from my phone in October 2020.

The screenshots display the October 5, 2020 message thread and the originating number shown on the receiving device.

I have retained the submitted image files without highlighting, cropping, or substantive editing.

I do not contend that the screenshots, by themselves, establish the actual subscriber, user, author, carrier routing, or technical origin of the displayed number. I request that those matters be determined independently through appropriate investigative or telecommunications records.

#### **6. Investigative purpose**

I respectfully request that investigators evaluate the temporal relationship between the pre-October 2020 publications and the October 5, 2020 SMS.

In particular, I request that investigators determine through independent investigative methods whether the sender, displayed telephone number, subscriber information, telecommunications records, device records, account records, associated persons, or other objective evidence connect with any individual, event, or subject documented in the earlier material.

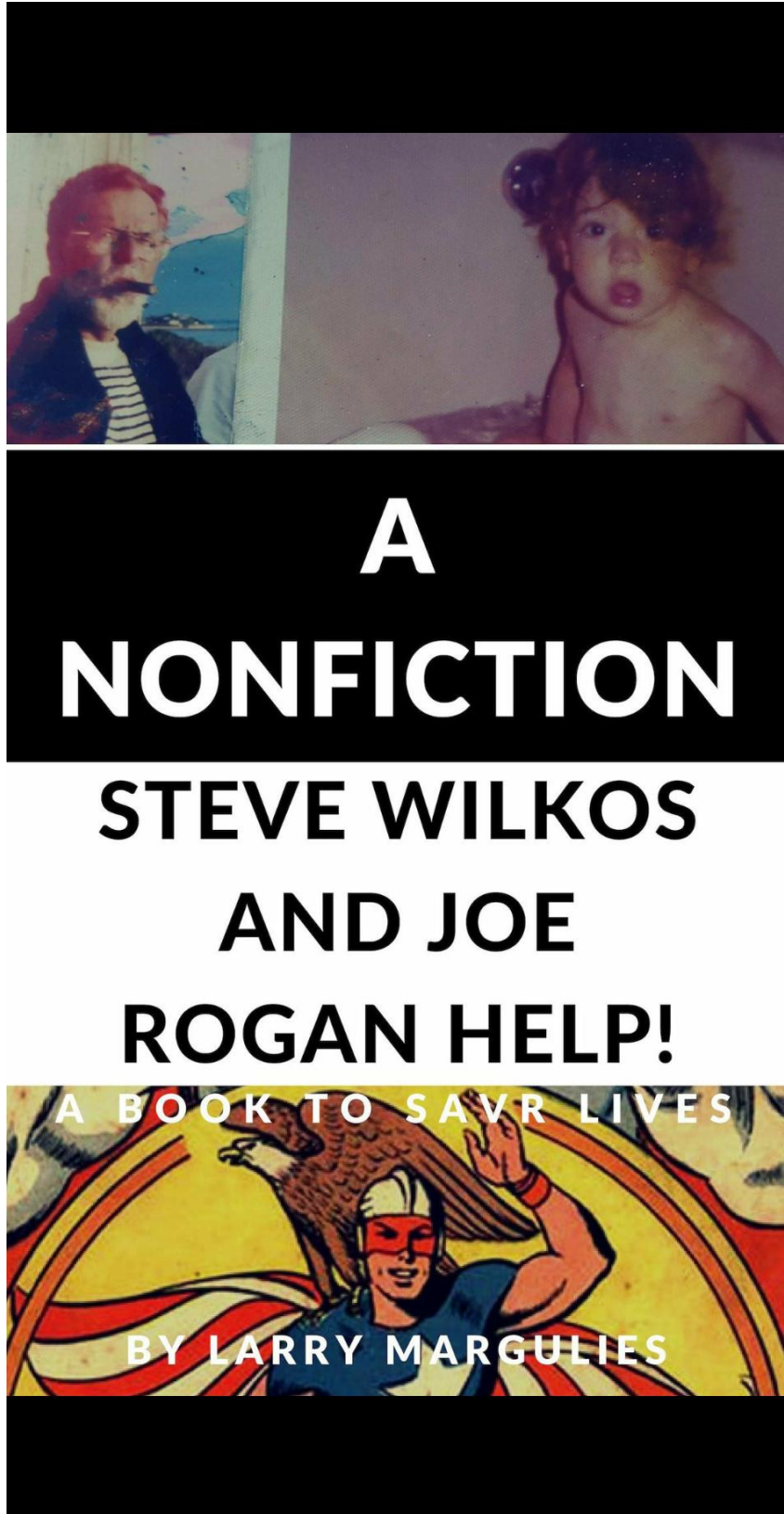

At our destination totally, new people greeted us and instructed us to drive under a bridge in the pitch black. The driver and I agreed not to do that and the man who greeted us then clearly said on his phone " the hit is canceled " . In Cebu when my mother had sent my high school transcripts to my hotel for me to apply to school, there also came a small crowd of men but they stayed opposite my hotel at another one named Kukus nest. Some of those men who came to Cebu asked me about Caymans and one American who had called me by my Hebrew name used in a sci fi story was seen near my room door when a paper resembling that fax to Caymans disappeared from my tidy red folder; that man also told me to look at his elbow. After that group left, a new man stayed there named David who claimed to have earned a purple heart, and he came up to me several times with his phone on; he stayed around more than a few months. I confronted David about the surveillance and said to him that I would have him investigated likewise; he then threatened to throw me overboard attached to concrete blocks and immediately made a phone call out to " have all phone records deleted. "

2014 Davao Philippines

I invited Lesyl from Cebu to Davao, and I applied to a university for my criminology degree and to open a coffee shop while I sat on my Nasdaq stock. An American named Jerry showed up at the coffee place offering to help me. My potential business

vention even though I had only smoked 1.2 ounce of weed in high school. I confronted my sister about this instead in a therapy session and she complained that she could get high because she did homework. I never had done my homework. I mostly sat at my desk just waiting in fear for being checked on.

My mother said she wanted us all to do homework together, but my father insisted we stay in our rooms separately; it was like he was running some controlled psychological experiments on us, and his friends generally said that he ran a family like a business. His friends also told him to stay away from me, but he did not. He used reverse psychology against me personally daily. Interestingly my dad showed me some sort of television he made himself early on in his career which he kept in the attic. He even kept an xxx-orgy film in a canister labeled "mother" Among our family albums, something he says was a film reel from one of his first law cases, I think it was something he used to blackmail those people in it. He kept something of mine also in his safe, he literally told me when I was about 11, that he would use it against me later as an adult.

Soon after the first attempts on my life began I made a special trip to Boston and spoke with my father and Paul Mcsweeney, his best friend and white-collar crime detective who stands at about 6 feet four inches and weighed about 400 pounds. Benny the diplomatic security agent whom I met during the 2008 Olympics had also been on his machine (my father sponsored my visit to Taiwan to meet him, and I think now that either he meant to entrap me or to make me out to be a 'patsy', he really should be subpoenaed to find out what he has to say about the attempt's on my life and the direct statement by the State Department of which he works for that "there is a warrant on my life" by "Whitey". I sent his photo to all my family's email accounts. Besides Paul McSweeney or my father's contacts, Benny claimed having a chloroform sales license and was engaged in covert work also).

I loved my family as much as I could, really, through all the abuse, but their abomination was real, their coldness never dissipated, until finally they took the thing I hoped all my life for, a child to start a new family. My poor child was literally tortured with a poison while squeezed to death in a few different attempts by my girlfriend. I was there and couldn't stop her physically. There also was a group of killers outside, and I could not take her to the hospital without money, and then I was also limited what I could do without marital rights. If the American men harassing and threatening me, the ones who strongly implied they work with the C.I.A, had not poisoned me several times then this beautiful child would have lived. These Americans are traitors to America and should be punished in public for what they did to me and the child, also the other lady and witnesses. I find it

from stopping these people from killing me. No one expected me to survive the attempts on my life and there were some very real reasons I did survive which I cannot share now. Now that I have, my family has been out of touch and even certified mail asking for related documents gets returned. Not only did my family admit and confirm verbally exactly what the assassins knew at the times of my assassination, but also during the attempts on my life I called my family for help and literally my mom said she'd only "think about it", and another attempt she said I "have nothing to do with that". After a different attempt or two my father said to me "you are very brave" with a snarl.

The people who tried to kill me in Baguio at the hospital included the Americans in Cebu who came to the house at 26 C Imus Highway when I applied for the repatriation loan. My father had said about those Americans (The gray haired American agent with two local policemen) "that's what you get for writing the letter". That letter was specifically one I wrote to the state department (with my application for a loaned ticket back to USA) writing that my life was being threatened and that my father was involved, so they relayed to my father what I had written and without a privacy waiver signed. In it I accused my father of hiring two other men who threatened my life in Hong Kong which was common sense, but my father's reputation preceded him, and he had much influence.

My sister, during the month before the baby and I were almost simultaneously killed, told me "that month would be the last time I spent with my girlfriend", Mike, eight years older, my eldest sibling, said that I would be "locked up or put in a hospital if I said anything about past abuses". In fact, after a violent attempted break-in to my apartment just before the murder of my baby my father told me to "go to a hospital" for no reason, and not the police station.

When I applied for the repatriation loan I told my father I was going to D.C to complain about the men harassing me and my father spoke as if he were disappointed in that plan; furthermore, he tried to stop me from going back to the states to complain about them, he also increased his slander of me to the state department that his opinion of me was "severely psychotic and a master manipulator" which is pure baloney, something completely without bases, but this is exactly when those people poisoned me with some very strong hallucinogen and it was no coincidence. I have never been diagnosed of anything more than a mild depression when I was a teen (except for the one month I was getting high with my friend Kevin and Nathan in 1989 and my father took me for a written test which I couldn't pay attention to)

Another of dozens of unbelievable coincidences that happen in my story was at that time of the poisoning my parents sent a letter to an old camp mate whom I reached out to help because he owed me a favor. As a child he said he would do anything for me. That man five years my senior is Nathan Y. Gross and a real pedophile who asked me for a blow or "sick favor" at ten years old. My father referred to him over the phone to me while in Cebu as having taken everything away from me but in fact only my father had, and this escalated the people my father had hired

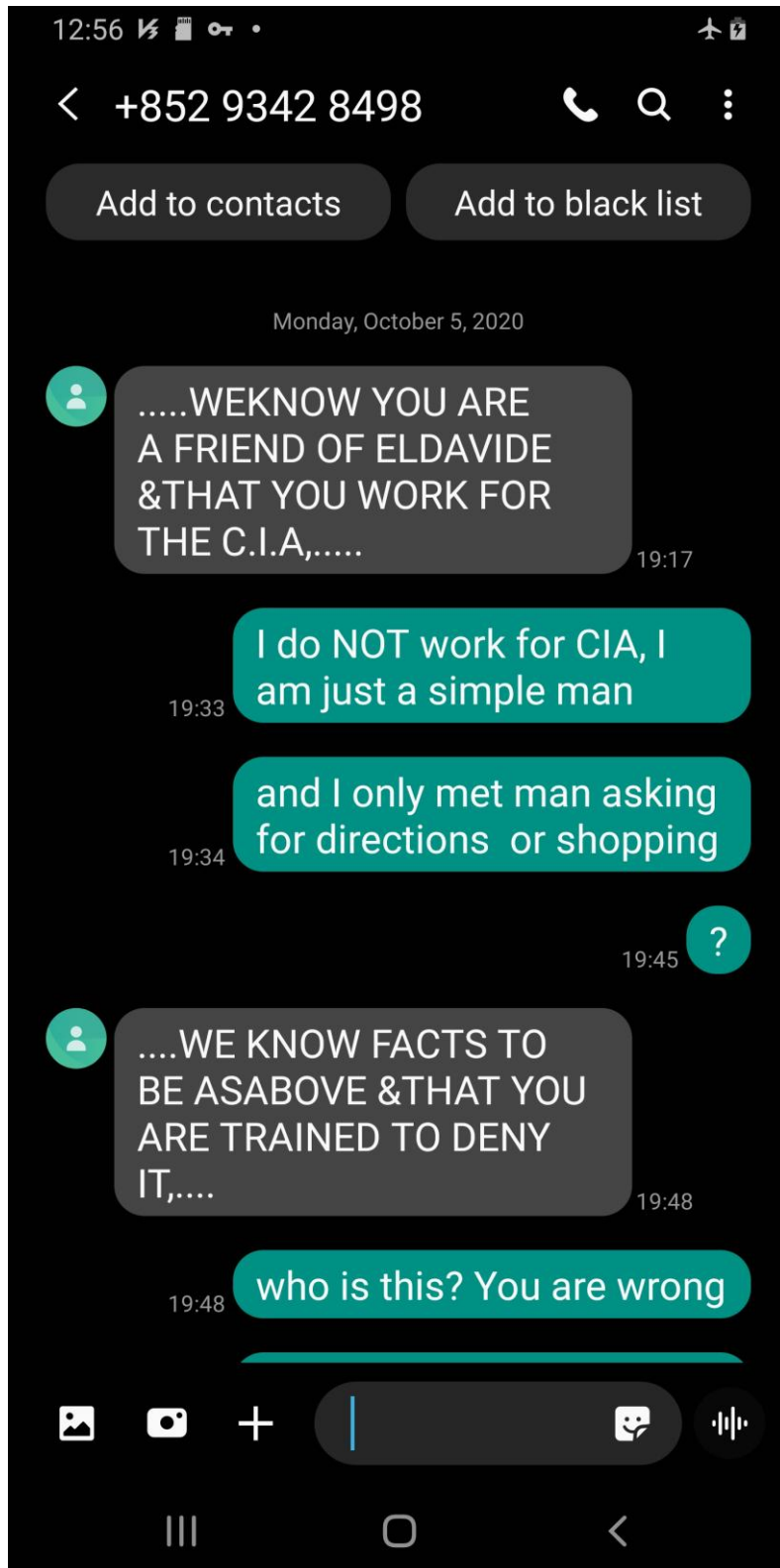

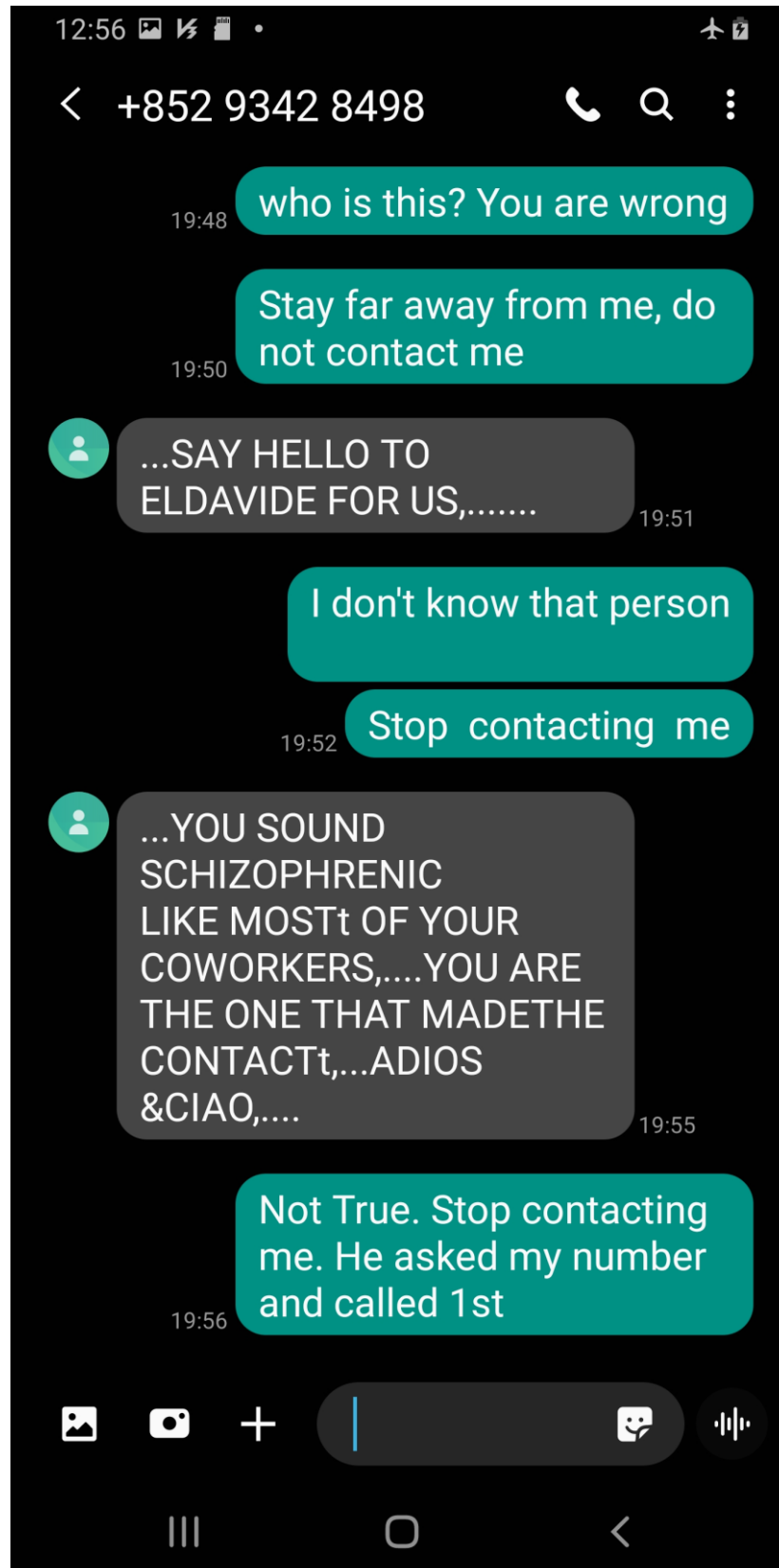
That hit team like others took orders from someone. They had forced her to help them to kill the child and me; she was trying her best to use this chance to tell what was happening and feeling her guilt.
