NOTICE OF CURRENT PROVISIONAL UNSWORN SUPPLEMENT
PENDING CONSULAR NOTARIZATION

Purpose	Preservation, investigative review, source clarification, and record- location pending formal consular notarization

1. I previously executed and submitted a Philippine Complaint-Affidavit notarized on 25 August 2026 at the Philippine Consulate General in Guangzhou (Doc. No. 0699; Page No. 215; Book No. 17; Series of 2026). That document remains the controlling sworn filing unless and until a later duly sworn supplemental affidavit expressly corrects or qualifies a particular matter.
2. I am now submitting the current revised provisional Supplemental Complaint-Affidavit dated 19 September 2026, including PH-S1/PH-S2 and the Gecko Bar / “Bill” and Lesyl Medalla / “Ruby” source-attribution clarifications, for receipt, preservation, investigative review, source comparison, and record-location without unnecessary delay.
3. This version supersedes, for present reference and investigative review only, any earlier provisional unsworn supplement I transmitted, uploaded, or made publicly available, including drafts predating the current clarifications. Earlier provisional unsworn versions should be treated as historical drafts. This does not withdraw, replace, restart, or renumber the original notarized Complaint-Affidavit or its original exhibits.
4. The current supplemental document has not yet been sworn to or notarized before a Philippine consular officer. I do not represent it as presently notarized or as a completed sworn affidavit. I respectfully request that the current provisional version, including PH-S1 and PH-S2, be associated provisionally with the existing notarized Complaint-Affidavit for investigative review, source comparison, record-location, and evidence-preservation purposes. PH-S1 and PH-S2 are submitted as supplemental documentary exhibits subject to authentication and do not renumber the original exhibits.
5. I intend to execute and notarize the current supplemental document before an authorized Philippine consular officer as soon as reasonably practicable and to submit that notarized counterpart afterward. When the notarized counterpart is submitted, I request that it be associated with the same matter and that only its express corrections or qualifications control over earlier statements on the specific points they address. I do not request that investigators delay appropriate preservation, record-location, witness-identification, or other lawful preliminary investigative steps solely because the notarized counterpart is not yet available.
6. Until the notarized counterpart is submitted, the current provisional material should be treated as supplemental investigative information and not as a substitute for the existing notarized Complaint-Affidavit. This status notice itself is not evidence that any allegation has been proven, is not a jurat, and does not itself notarize the supplemental document.

REQUEST

Please associate this notice and the current provisional Supplemental Complaint-Affidavit dated 19 September 2026, including PH-S1/PH-S2 and the current clarifications, with the existing notarized Philippine Complaint-Affidavit; preserve them in the case file; treat earlier provisional unsworn drafts as superseded for current reference; and accept and associate the notarized counterpart when later submitted.
