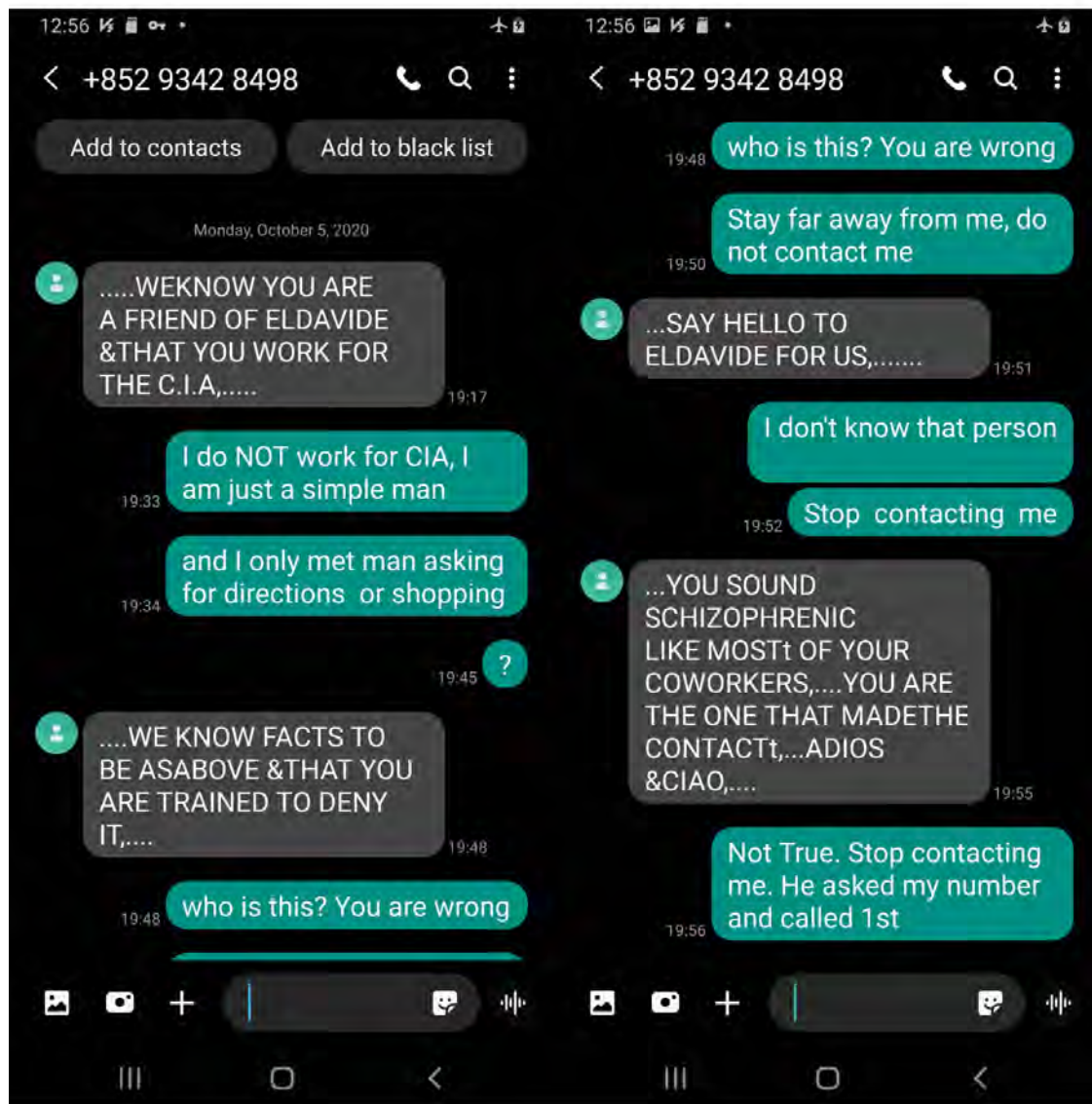

Dear Mr. Hamer,

Thank you for this invoice.

I am assuming that the black/red areas have been blocked out by you for confidential reasons. However, if they have been blocked by Larry, then I am very suspicious of the credibility of this invoice. It appears that this is an invoice for Larry to have diagnostic testing, not for treatment. Who is requesting for him to be tested? and what are Larry's plans for suggested treatment after completion of testing?

Also, he has been diagnosed in the USA as having a mental illness. It seems to me that he is trying to get a new diagnosis for legal reasons and not for getting medical care. I think he is trying to substantiate a case against his family, proving that he is not mentally ill and not address his medical needs. After researching psychiatric rates in Hong Kong, they vary amongst the private sector and these rates are at the extreme end of things. There are many psychologists in Hong Kong whom Larry can contact for much lower fees. A report is part of the diagnosis, not an additional \$30,000.00 and a report would not be withheld after hours of testing.

Again, making me think this is not a real invoice.

For Larry to agree to this amount before having financial back-up is highly irresponsible and should not be for me to decide after he has the treatments. I would like to have the name of the doctor who is doing this testing.

This does not break confidentiality. I need to verify this clinical psychologist before any payment is even considered, especially based upon Larry's past history. Lastly, in the past, Larry has received a lot of money for college, for hotels, for tuition, etc and never attended any classes or completed the courses. What guarantee is Larry giving that he will complete all these tests and follow through with treatment.

Dear Mr. Hamer,

I have given this a lot of thought.

A few things come to mind. Knowing the place where he receives therapy is not an issue of confidentiality; perhaps for Lawrence it is but legally, I don't think so. I consider a breach of confidentiality would be having direct contact with the actual therapist.

With this said, I had help exploring the invoice you had provided and discovered the name of the therapy center (Jadis Burton Family Development Center) where Larry proposed receiving the assessment. I have reached out to them to get a quote of the tests listed on the invoice along with the report to find out that it would cost only \$24,000 HKD and payment can be thru online transfer or PayPal. This includes the report which is provided 6-8 weeks after the assessment.

In addition, it was discovered that Larry's invoice could be and probably was altered thru a PDF editing program. It was not originally created using a proper invoice billing software program. So, I am assuming that Larry has added the last line of \$30,000 HKD for a report since a report is included in the above-mentioned fee. I think that the Development Center would have used a proper billing program so I can only assume that the one Larry provided was not an original invoice.

Being that it is now February 7th, do you have any proof that Larry had actually begun the assessment process, which was started on the invoice as beginning Feb. 4 and Feb. 5? Do you have proof that he has paid for the services or at least a partial payment? This center would not initiate the assessment without a deposit.

In the past, I have paid for services, classes, rent, etc of which Larry did not attend or was even present.

I hope you can understand my decision as I really feel every issue needs to be examined and questioned thoroughly. I do want to help him with his medical needs but feel that at this time, with what has been provided,

I am uncomfortable assisting.

If he is pursuing using a therapist at the Jadis Burton Family Development Center and the Center can provide documentation, then I will pay them directly via their online transfer system.

RELEVANT BACKGROUND

Mr. Margulies reported that he was born and bred in the United States of America. He is the youngest child in the family of 4 children. He described a childhood characterized by adverse childhood experiences which included an unhealthy family environment. He added that his mother was a submissive woman who could not stand up for herself in the family. And he described his father as domineering figure in the family.

Furthermore, Mr. Margulies reported that his mother had told him his siblings ill-treated because they were jealous of him. He stated that the toxic family environment affected his childhood severely, including his academic performance and behaviour. He reported that the problems with his family worsened a few years ago when he mortgaged a house and took the money with him to Hong Kong. He said his family felt betrayed by his decision because he had promised to live in Canada six months of the year. He added that the second reason his family wanted to harm him was because they had found out that he knew about his 1979 psychological report. He indicated that the family wanted to hide it from him because it contained evidence suggesting that his parents did not protect him when he was a child. He reported that revealing this information about his parents would have destroyed their reputation as they were well known philanthropists in the community. Lastly, Mr. Margulies mentioned that his mother wanted to silence him after finding out that he had told his brother about the abuse he suffered.

His parents also found out that he discovered a report about the mortgage by using private investigators. He said he received a threatening text message from a person named David who threatened to kill him by tying his feet to a concrete and then throwing him into the ocean. Mr. Margulies believes that his family hired an organization, such as a security company with family personnel contacts and many resources to track him and possibly harm him. He said the family described him as a manipulator, liar and mentally ill person who is unable to manage his life. According to him, he was subjected to intimidations and threats from people he described as mercenaries who were hired by his family to kill him.

He reported that a team of resourceful people were hired by his family to follow him wherever he went, including being followed to 10 countries he travelled to in the past few years. He indicated that these people stalked and threatened him in Hong Kong. He said that he and his girlfriend were visited by that group of people to continue to threaten and intimidate him. He added that another person informed him that his girlfriend, pregnant at the time, was approached by someone who wanted her to betray him so that they could harm him. He indicated that his girlfriend experienced severe pain and later told him that the the baby was moving too slowly inside her womb. He said he suspected that she may have been given poison to harm his unborn baby.

Mr. Margulies shared a letter which he said was written by his then girlfriend. The letter describes in detail how Mr. Margulies' life and that of his then girlfriend was in danger as they were being followed by unknown people that had an intention to harm them. In the letter, she mentioned that the strangers approached her and promised to give her everything she wanted if she agreed to betray Mr. Margulies. She also confirmed that they lost their baby during the same period when the strangers arrived. Mr. Margulies said he had to bury his demised baby alone without the help of the hospital. But he mentioned that he was able to keep a piece of the deceased baby's hair inside his bag as evidence that she was poisoned. But he reported that the bag was stolen and has not been found. As part of the evidence, Mr. Margulies shared a police complaint filed by his then girlfriend on the 21 July 2015 at the police station in Manila, Philippines where she reported the suspicious individuals who were stalking her.

He reported that his oldest brother warned him the day before they came to his girlfriend's house. He mentioned that his other brother told him that their father had asked him to help kill Mr. Margulies. His oldest brother then requested that he should write a letter appointing him (one of the brothers) as the trustee of a trust account. The group of men threatening him also told him of the trust account. He mentioned that three years later his lawyer gave him a copy of the trust document which indicated that his siblings would gain equal portions of the money meant for him if he died. He indicated that one of his brothers whom he said had a finance degree also stated he helped their father draft that document. Although Mr. Margulies mentioned that his family labelled him a liar and mentally ill, a report compiled by Christina Ramos, a psychologist concluded that Mr. Margulies was of sound mind and mentally fit. However, Christina noted that he has difficulty trusting people and can appear to be distant and aloof.

A letter written by his long-time friend who has known him for 34 years, Nguyen Weeks, also reported that Mr. Margulies was of stable mind and showed no signs of mental disturbances. The letter from Nguyen confirmed what Mr. Margulies has reported about his parents, especially that his father had propensity towards violent and aggressive behaviour. Nguyen expressed misgivings about Mr. Margulies' father following an incident in which his father behaved violently in his presence. Nguyen reported that he witnessed Mr. Margulies' father ramming the car he was driving against his car. He also detailed at length how Mr. Margulies was traumatized by his own father. Another friend, Mr. Michael Zhang prepared a support letter that described Mr. Margulies as a mindful, helpful, thoughtful and kind person. Mr. Zhang denied that Mr. Margulies showed any signs of mental health problems. He described him as mentally stable despite the many personal difficulties he faced throughout his life.

Past Medical History

He reported that he has a history of sustaining some undefined fractures.

Past Psychiatric history

Although Mr. Margulies consulted a psychologist as a child, at the age of 8, no formal diagnosis was made. Since then, Mr. Margulies underwent 2 more psychological evaluations, including one conducted by me in 2021. Both assessments revealed no apparent psychological disorders.

MENTAL STATUS EXAMINATION

- **Appearance:** Mr. Margulies presented to the session well-groomed. He was alert and was able to establish rapport with ease. He was forthcoming with information and engaged well in the sessions.
- **Behaviour:** He was able to maintain good eye contact during the session. No tics or unusual mannerism observed during the assessment.
- **Speech:** His rate and flow of speech were normal. His intensity of volume was normal.
- **Mood and affect:** His mood was mostly euthymic with an expressive, congruent and appropriate affect. He expressed feeling overwhelmed and frustrated by the abuse he has been subjected to by his family.
- **Thought Patterns:** His thoughts were clear, coherent and logical. But he complained constantly about being persecuted by his family and the strangers hired to harm him.
- **Cognition:** Mr. Margulies was oriented to space, time and person. His attention and concentration were good. He did not display significant memory problems during the session.
- **Insight:** He showed fair insight into his problems. He was able to come to appropriate conclusions regarding his problems and how they should be resolved.
- **Judgment:** He displayed fair judgment.
- **Suicidality/Homicidal thoughts:** He denied feeling suicidal or having any suicidal thoughts.

ASSESSMENT RESULTS

It should be noted that while test scores are given here, errors of measurement are possible in all tests of this type, so Mr. Margulies' true emotional state may be slightly better or worse than indicated by these scores. Psychometric tests only provide a 'snapshot' of a person's performance. Therefore, the results should be interpreted cautiously and considered alongside this information provided.

International Personality Item Pool (IPIP-120)

The International Personality Item Pool (IPIP-120) is a comprehensive questionnaire designed to measure personality traits based on the Five Factor Model (FFM). This 120-item assessment evaluates five key dimensions: Openness, Conscientiousness, Extraversion, Agreeableness, and Neuroticism.

Results

Openness to Experience Factor

His score on **Openness to Experience** is **low**, suggesting that he appreciates routine and prefers familiar environments. He is likely to be pragmatic and down-to-earth, focusing more on concrete information rather than abstract theories or ideas. This trait also indicates he might be resistant to change and new ideas, tending to be more cautious and less interested in novelty or exploring unfamiliar concepts. **His imagination is low.** Low scorers on this scale are more oriented to facts than fantasy. **His liberalism is also low.** Psychological conservatives prefer the security and stability brought by conformity to tradition, authority, and convention. These results are consistent with how he described himself as being generally conservative but also open to new and adventurous experiences as described by his friend.

Conscientiousness Factor

Mr. Margulies' score on **Conscientiousness** is **high**, suggesting that he is responsible, organized, and reliable. He is likely to be very detail-oriented and plan things carefully, preferring to follow schedules and set routines. He approaches tasks in a methodical and disciplined manner, consistently meeting deadlines, and his strong sense of duty often makes him a dependable team member or leader. His orderliness is high. People with high scores on orderliness are well-organized. They like to live according to routines and schedules. They keep lists and make plans. **His dutifulness is high.** This scale reflects the strength of a person's sense of duty and obligation. Those who score high on this scale have a strong sense of moral obligation. His achievement striving is low. Low scorers are content to get by with a minimal amount of work and might be seen by others as lazy. The result within this dimension is consistent with his friend's description of him as being kind, resourceful and thoughtful of others.

Extraversion Factor

His excitement seeking is also low. Low scorers might feel overwhelmed by noisy and busy environments and may be averse to thrill-seeking. As explained earlier, it is apparent that Mr. Margulies was not always someone avoiding new and challenging experiences, it is possible that his disposition may have changed due to the difficulties he faced in the past, especially the multiple threats to his life as evidenced by the statement from his former girlfriend and the text messages he received from strangers.

Agreeableness Factor

Mr. Margulies' score on **Agreeableness** is in the **average range**, meaning he has a balance between taking care of his own needs and considering the needs of others. He can be cooperative and compassionate when it's necessary, but he is also capable of asserting himself and expressing his own needs. He can maintain a good balance between empathy and self-interest. **His trust, however, is low.** People who are low in trust assume that most others are selfish, non-truthful, and devious. But his altruism is high. Altruistic people find helping other people genuinely rewarding. Consequently, they are generally willing to assist those who are in need. Altruistic people find that doing things for others is a form of self-fulfillment rather than self-sacrifice. It is not surprising that Mr. Margulies scored low on trust in others. This is something that he expresses very often as he is scared for his life. He is untrusting in his family and other people whom he cannot understand their intentions.

Neuroticism Factor

His score on **Neuroticism** is in the **average range**, which means he is likely to have a balance of emotional highs and lows. Mr. Margulies is generally calm and emotionally stable, but can still experience periods of worry, stress, or negative emotions, particularly in response to life's ups and downs. His level of emotional sensitivity allows him to be resilient, while still being in tune with his emotions and the emotions of others. **His anger is low.** Low scorers do not get angry often or easily. His facet of **self-consciousness is low.** Individuals low in self-consciousness tend to display a high level of self-assurance and confidence in various situations. They are comfortable being themselves and do not constantly worry about how others perceive them or seek validation from others. Mr. Margulies' **immoderation is high.** High scorers feel strong cravings and urges that they have difficulty resisting. They tend to be oriented toward short-term pleasures and rewards rather than long-term consequences.

CONCLUSION AND DIAGNOSIS

Mr. Margulies reported a long history of feeling unsafe and expressing distrust in his family, whom he reported had declared him a liar, mentally unfit and that they are out to harm him. He described a long history of maltreatment during his childhood, long-term and harmful behaviors perpetuated by his family, both parents and siblings. Mr. Margulies has also experienced multiple incidents which may have solidified his lack of trust in his family. As reported earlier, he shared some documents that he said proved to be evidence of threats to his life.

Mr. Margulies was assessed in the past by Christina Ramos and the findings indicated that he was "*cool, distant and aloof in his interpersonal relationships*". Furthermore, he was described as uncomfortable when dealing with people that he perceives to be "*overly friendly and familiar*" with him. This description is consistent with the **International Personality Item Pool (IPIP-120)**'s **Agreeableness Factor** findings that he was low in trust. It is not uncommon that someone with his history may experience a high level of mistrust and general uneasiness daily, especially in his interaction with people whom he cannot "read" their intentions. Mr. Margulies may come across as paranoid due to his long-term pattern of distrust and suspicion of his family and strangers that he believes have been employed by his family to harm him. However, at present Mr. Margulies does not present any significant clinical symptoms suggestive of any mental illness. He is unlikely to be experiencing significant depressive symptoms and therefore has a lower risk of depression, with few or no symptoms impacting his daily life. He appears to possess coping strategies that aim to regulate his emotions associated with the stressful situation he experiences throughout his life. He has displayed resilience despite what he has been through, and this is indicative of psychological strength, grit, a practical approach to problem solving and is predictive of positive outcomes.

Diagnosis

Although Mr. Margulies has experienced multiple traumatic experiences, he does not meet the DSM-5 criteria for the diagnosis of PTSD, Adjustment Disorder, Major Depressive Disorder or anxiety disorder which are normally associated with a history of adverse life experiences.

RECOMMENDATIONS

Mr. Margulies is currently functioning well, mentally fit and shows no signs of significant clinical impairment, it is my professional opinion that if he agrees he may benefit from the following support to deal with his traumatic past as well as the recent events that have threatened his life:

- **Cognitive processing therapy (CPT).** This technique is used to help process trauma, since many people can't process it directly after it happens. CPT can also help someone restructure their beliefs around what happened in more helpful ways.
- **Eye movement desensitization and reprocessing (EMDR).** EMDR uses gentle tones or tapes to interrupt thought patterns or beliefs. This form of therapy or intervention can reduce anxiety, depression, fatigue, and paranoia.

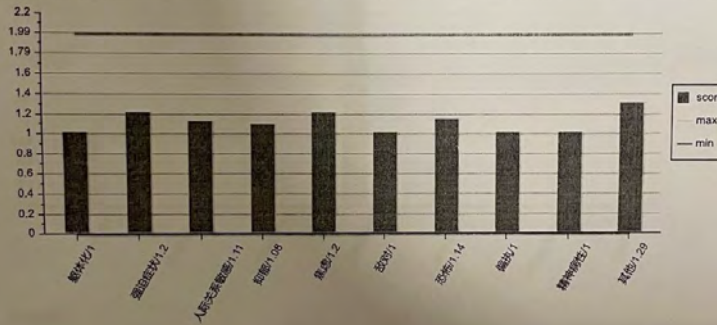

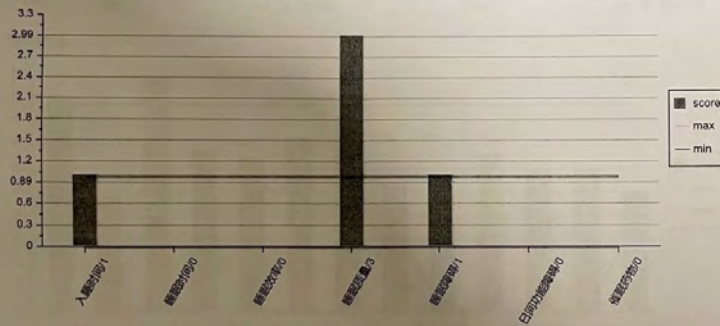

Exhibit 8: A 1979 psychiatric report page documenting Martin Yudowitz's long history of violence toward me as a child, for which he received outpatient psychiatric care, and Evelyn Yudowitz's medical negligence in denying me therapy, which she later concealed through redactions and deception. In a 1995 therapy session, Evelyn presented a heavily redacted version of this report while seeking forgiveness for locking me in my room for two years, indicating her intent to hide her actions. Her psychiatrist later confirmed she lied about our home environment, claiming it was fine when it was definitely not, which convinced him there was no need for my therapy. This allowed Evelyn to hide the abuses and maintain a false narrative that harmed me. These events, combined with my pursuit of the unredacted report, demonstrate a decades-long pattern of concealment relevant to the charges

once the valve was turned from "off" to "on" a flood of diffuse aggressiveness poured out.

At the level of awareness, Lawrence could talk about (1) his fear of monsters and of the attic in his house; (2) his view that father works too much and "talks and talks"; (3) his complaint that brother, Martin, who provokes fights and Lawrence runs to brother, Mike, for protection; and (4) his special "erotic" tie to mother (e.g., "we kiss each other every night.").

In summary, Lawrence is a very bright seven year old who is at present hampered by intense diffuse anxiety as he moves beyond the oedipal stage into latency, because appropriate defenses and cognitive control functions have not organized. This anxiety is interfering significantly with academic and cognitive development and functioning. His teasing, bad language, preoccupation with penises, etc. are understood by us as the by-product of phallic drive development which, however, is not appropriately organized by cognition and defenses. His usual attachment to mother - including his immature speech - could be viewed as an attempt to use regression in an effort to manage his current predicament.

Psychotherapy is strongly recommended and should promote cognitive-ego growth; academic and cognitive remediation would be indicated only if after a year of therapy, he shows that ego compromises have been fixed to a degree which the psychotherapy process cannot alone free. Without intensive therapy more severe ego and emotional symptoms are likely to crystallize.

My name is Nguyen Weeks and I work in an Organizational Development Department that supports the leadership and development of Healthcare workers across the State of California. I possess a Bachelor of Science in Marketing Communication from Emerson College and a Masters in Public Administration from the University of San Francisco.

I have known Lawrence "Larry" Yudowitz for 34 years. We met while in a mutual class together in the 10th grade. Although decades have passed, we remain in contact and remain friends.

In addition to our friendship, it was customary for my mother to meet all of my friends. She believed that all my friends were a part of a network of people she wanted to be engaged with. Larry met my mother on numerous occasions and they would engage in thoughtful, and heartfelt discussions while we were in high school and beyond.

It is my understanding that individuals in his family are attempting to state that he has mental health issues that impact his ability to think, live or build a life for himself. In all of the years I have known Larry, I have never known him to exhibit mental health challenges outside of the typical youth and young adult development phases and experiences that shape the lives of young people.

My second interaction with his father made me ponder about how children create behaviors to deal with traumatic situations in their lives and what impacts a household with excessive controls produces.

On the second visit to see Larry, I brought a family friend (Odessa) who resided in Newton, a neighboring town, to come socialize. On this particular day, as we rode through the back roads, which were dark because it was past sunset and because it was heavily shaded, Larry spotted his father's car and he froze and pulled over on the side of the road. My friend and I had no idea what to expect at that moment. Larry walked over to his father's car and they started to argue. When Larry got back into the car, his father took his Cadillac and rammed it into the side of the Saab on the passenger's side. This seemed erratic and extremely scary because we were in a very remote location, we did not really know his father and there is a car being used against another car. My friend and I got out of the car and Larry's sister got into the car and drove away. Larry's father told us that we should go home. As we walked (45 minutes) to the closest train station, we were bewildered that his father would show this level of violence, and it was in public, although whether in private or public, I did not feel it was merited, nor a productive way to get to the end result he was hoping for. As a person outside of the family, it was shocking, harmful and I would even go as far to say traumatic. My friend and I were bewildered and fearful of Dr. Yudowitz.

We wondered what the real life implications were for Larry especially when at this phase of life it is customary for teenagers to express more of their independence and question those in authority.

Despite that experience, it was clear that Larry had a dichotomous relationship with his father. On the one hand, he absolutely revered him and respected his accomplishments, and at the same time, there was always an underlying theme of fear woven into the relationship. Larry always sought the love, nurturance, and guidance from his father, but the relationship was strained and it had its limitations.

Larry has always been a kind individual, who when motivated, will put his all into what he wants to accomplish. Larry can be pensive and thoughtful about his interactions. He has always taken chances where others may be more risk averse, whether it's business or travel. Larry is also resourceful and a strategic thinker who has ventured across the globe making relationships and building a life that affirms who he is and what he wants to do in the world.

It is my belief that during his childhood, Larry faced traumatic experiences that shaped him, that required coping strategies, but even with that, he is a person that would go against the grain - challenged what he thought was not right, questioned the notion of blind acceptance of harmful behaviors and actions by authority figures and has charted a life that allows him to build the life he wants.

2. During that period of time, we rented an apartment in Tan-awan Village, Baguio City;
3. Sometime on January 2016, my boyfriend Larry Margulies decided to visit a doctor for a regular medical check-up. We went to the hospital near the place we stayed. We arrived in the hospital at about 8:00 o'clock in the morning. Larry went inside the clinic of the Doctor and I stayed outside of the hospital;
4. While, I was waiting for Larry, I noticed a commotion in the hospital, thereafter, the security guard called me and told me to ask Larry to go back inside the clinic of the hospital to finish the check-up. There were four guards who stopped Larry from leaving the hospital;
5. I saw Larry looks so scared, while the Guards were holding him.
6. I asked the doctor to allow my boyfriend Larry to go home because he already paid all the bills. However, the doctor insisted to finish the check-up;
7. But, Larry told me that we had to leave right away and that he noticed something unusual inside the clinic that made him scared ;
8. I was also afraid, so I asked the guards to allow Larry to go out from the hospital grounds but the guards still refused. Then, I told the guards to call a police but they did not;
9. Few minutes later, a lady showed up wearing plain clothes but without any ID. She came from the street corner where the private hospital road end. She came with the four (4) other guards and said that the doctor wanted him to go back and insisted to bring back Larry inside his clinic to finish the check-up. However, Larry said that he paid all his bills and he does not want to finish the check-up. Thereafter, the four guards and lady released Larry;
10. From the hospital, we went directly to the bus terminal in Baguio and took a bus for Manila;

11. We were not able to report the incident to the Police in Baguio City and we failed to get the name of the doctor because we were in a hurry to go back to Manila for my boyfriend's safety;

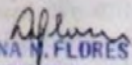

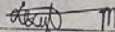

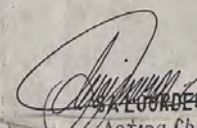
