We are thrilled to welcome you for this first combined IFA meeting between Switzerland and Italy since 2008.

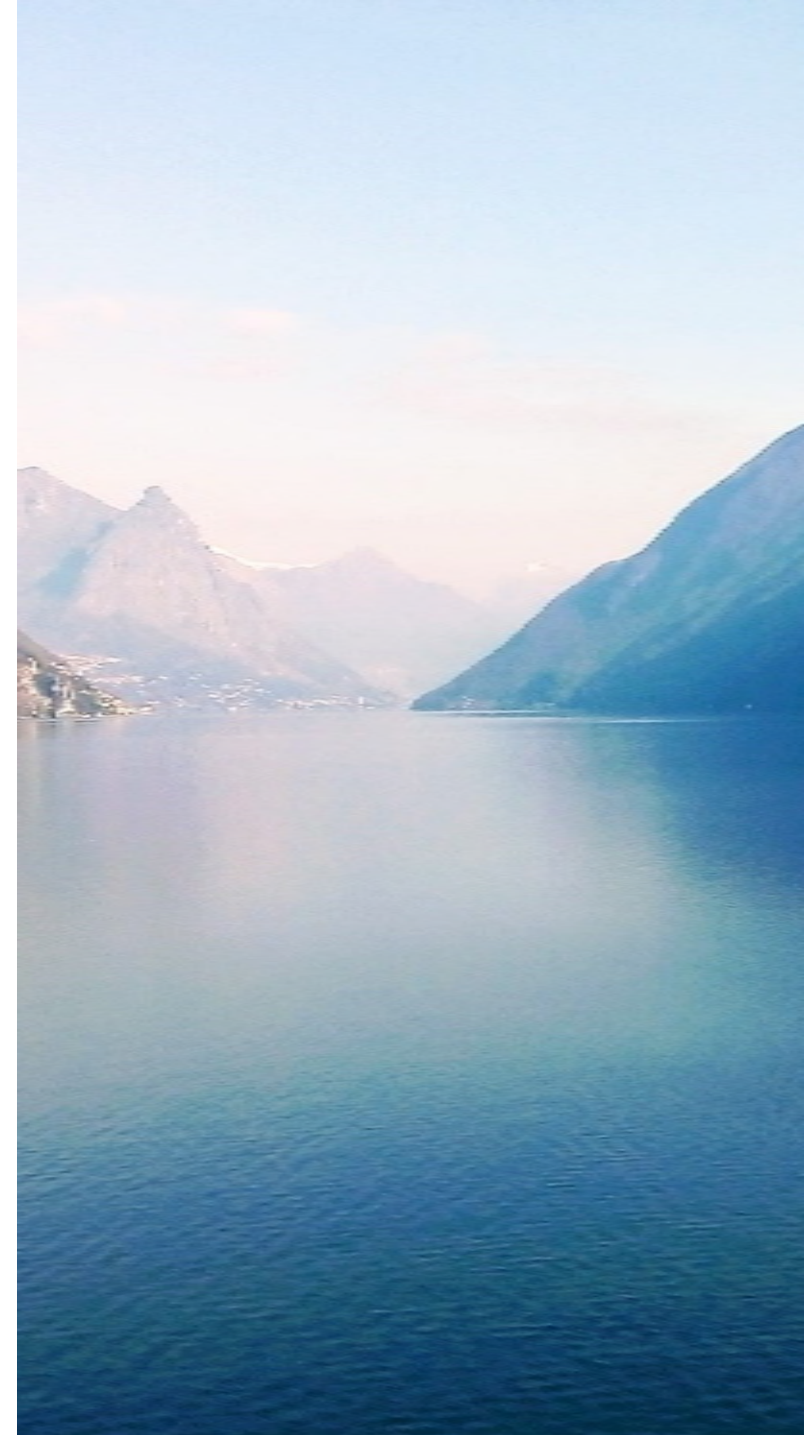

The presentations and discussions will be on-site and in English language only.

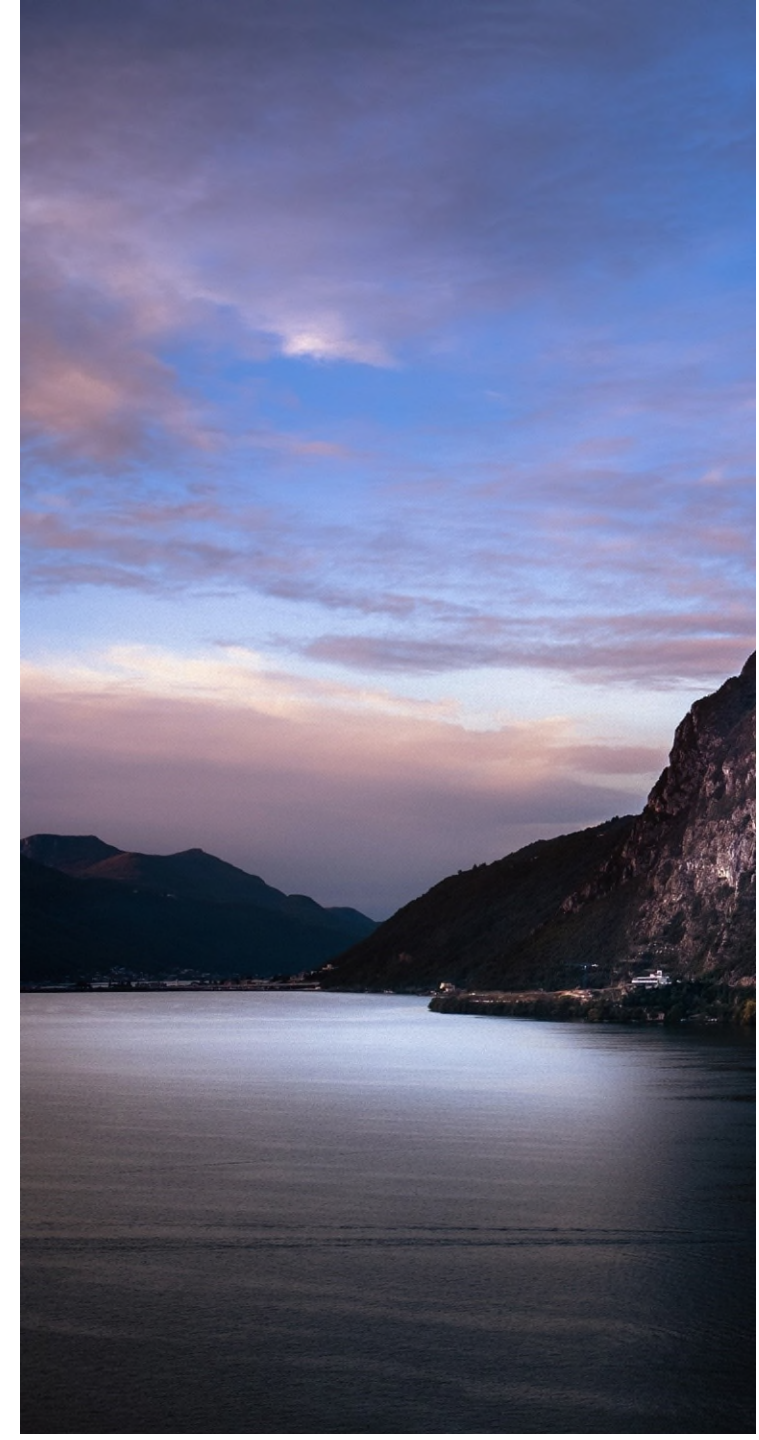
