Tax overview

State corporate income tax (DE): 0% on income earned outside Delaware

Franchise tax: ~\$300/year

Filing: annual

Sales tax in DE: none

The U.S. is ideal for

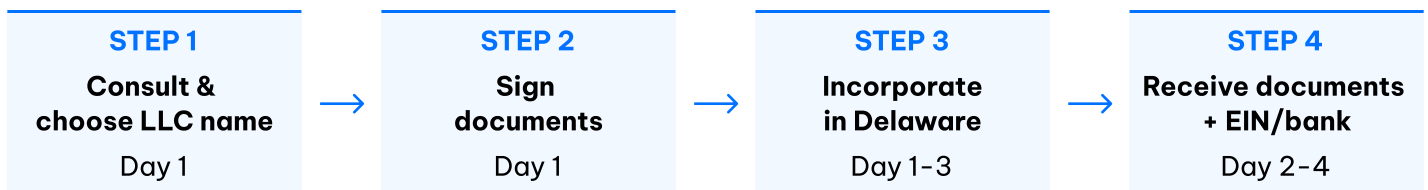
- Solopreneurs / freelancers serving U.S. clients

- International payments (Stripe/PayPal)
- Startups needing U.S. entity to sign & raise funds
- Businesses needing a USD account

Annual compliance (from year 2)

- Renew Registered Agent
- File Delaware Franchise Tax (~\$300/year)
- Federal filings (Form 5472 + 1120)
- Bookkeeping & tax filing

Incorporation process (2-4 business days from receipt of all documents)



3 important notes

1. Foreign owners must file federally every year (Form 5472 + 1120), even when tax is \$0; omissions can carry heavy penalties.
2. An EIN is required to open a bank account / Stripe – Speedy assists with the EIN application.
3. Forming a company does not automatically guarantee approval of a U.S. bank account.
