This is to verify that the above-mentioned product does not contain any of the 211 Substances of Very High Concern (SVHC) identified by the REACH Regulation in their compositions.

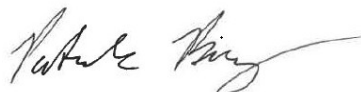
