This product contains Coumarin and Limonene (d-alpha), both of which are listed in the EU Cosmetics Regulation 1223/2009. These 2 substances are naturally occurring in Calendula and are present in amounts of $\leq 0.05\%$.

Genetically Modified Organisms:

Bio-Botanica, Inc. confirms that none of the ingredients used in its preparation or manufacturing of the above-mentioned product has been subject to or derived from genetically modified sources. It is also free from both genetically modified DNA and the proteins derived from genetically modified DNA.

Therefore, this product is non-GMO.

Vegan/Vegetarian:

Bio-Botanica, Inc. confirms that the above-mentioned product is vegetarian/vegan. No raw materials with animal derivatives have been used in the manufacturing of this product.

BSE/TSE Statement:

Bio-Botanica, Inc. certifies that the ingredients in the above-mentioned product is not derived in whole or part from animal sources and does not utilize animal derivatives in its manufacture. Additionally, this material complies with the FDA interim rule effective January 12, 2004 (9 CFR Parts 309, 310, 311, 318 and 319) regarding prohibition of Specified Risk Material (SRM) for human food and Requirements for the Disposition of Non-Ambulatory Disabled Cattle. This product is non-BSE & non-TSE.

Prop 65:

Bio-Botanica, Inc. confirms that the above-mentioned product is compliant with the State of California's Proposition 65; whereas, to the best of our knowledge, this product does not contain any chemical known to the State of California to cause cancer, birth defects or other reproductive harm.

Animal Testing/Cruelty Free:

Bio-Botanica, Inc. confirms that the above-mentioned product has not been subject to animal testing and is considered cruelty free.

Food Grade Statement:

Bio-Botanica, Inc. confirms that the above-mentioned product complies with general principles of food law defined in the European Regulation 178/2002/EC and US Federal Food Drug and Cosmetic Act. Therefore, the ingredients within the formula are food grade quality and can be ingested.

GRAS Status:

CMR Statement:

Residual Solvents Statement:
