This product contains Limonene, Caryophyllene, Mentha Piperita Oil, Menthol, and Alpha-Pinene which are naturally occurring in Peppermint Leaf Extract.

This product does not contain any of the other 77 substances listed in the EU Cosmetics Regulation 1223/2009

Genetically Modified Organisms:

Bio-Botanica, Inc. confirms that none of the ingredients used in its preparation or manufacturing of the above-mentioned product has been subject to or derived from genetically modified sources. It is also free from both genetically modified DNA and the proteins derived from genetically modified DNA.

Vegan/Vegetarian:

Bio-Botanica, Inc. confirms that the above-mentioned product is vegetarian/vegan. No raw materials with animal derivatives have been used in the manufacturing of this product.

Additionally, this material complies with the FDA interim rule effective January 12, 2004 (9 CFR Parts 309, 310, 311, 318 and 319) regarding prohibition of Specified Risk Material (SRM) for human food and Requirements for the Disposition of Non-Ambulatory Disabled Cattle. This product is non-BSE & non-TSE.

Prop 65:

Bio-Botanica, Inc. confirms that the above-mentioned product may contain trace levels of furfuryl alcohol due to the presence of caramel color. To the best of our knowledge, this product does not contain any additional chemicals known to the State of California to cause cancer, birth defects or other reproductive harm.

Animal Testing/Cruelty Free:

Bio-Botanica, Inc. confirms that the above-mentioned product has not been subject to animal testing and is considered cruelty free.

GRAS Status:
