The following food allergens are NOT present in this product:

Wheat or wheat derivatives, Milk/Dairy Products, Fish (e.g. salmon, cod, flounder), Crustacean Shellfish (e.g. shrimp, lobster, crab), Soy or soy derivatives, Peanuts, Tree Nuts (e.g. almonds, cashews), Egg or egg derivatives, Sodium, Celery, Mustard, Sesame seeds, Lupin, Sulfur Dioxide/Sulfites, Mollusks, Yeast or yeast derivatives

The following food allergens are present in this product:

Corn or corn derivatives/Cereal Grains – Ethanol

Cosmetic allergens NOT present in this product:

This product does not contain any of the 82 substances listed in the EU Cosmetics Regulation 2023/1545

Genetically Modified Organisms:

The above-mentioned product contains ethanol that is derived from corn. Due to high refinement used in the manufacturing process of the raw material, no GM or DNA would be detectable in measurable amounts. However, we note the corn used to produce ethanol may or may not be sourced from GM corn.

As a result, we are unable to support a Non-GMO status. To the best of our knowledge, the final product is GMO free.

Vegan/Vegetarian:

Bio-Botanica, Inc. confirms that the above-mentioned product is vegetarian/vegan. No raw materials with animal derivatives have been used in the manufacturing of this product.

BSE/TSE Statement:

Bio-Botanica, Inc. certifies that the ingredients in the above-mentioned product are not derived in whole or part from animal sources and does not utilize animal derivatives in its manufacture. Additionally, this material complies with the FDA interim rule effective January 12, 2004 (9 CFR Parts 309, 310, 311, 318 and 319) regarding prohibition

of Specified Risk Material (SRM) for human food and Requirements for the Disposition of Non-Ambulatory Disabled Cattle. This product is non-BSE & non-TSE.

Prop 65:

Bio-Botanica, Inc. confirms that the above-mentioned product is compliant with the State of California's Proposition 65; whereas, to the best of our knowledge, this product does not contain any chemical known to the State of California to cause cancer, birth defects or other reproductive harm.

Animal Testing/Cruelty Free:

Bio-Botanica, Inc. confirms that the above-mentioned product has not been subject to animal testing and is considered cruelty free.

GRAS Status:

The Federal Food, Drug, and Cosmetic Act defines a dietary ingredient as a vitamin; mineral; herb or other botanical; amino acid; dietary substance for use by man to supplement the diet by increasing the total dietary intake; or a concentrate, metabolite, constituent, extract, or combination of the preceding substances.

Bio-Botanica, Inc. confirms that the above-mentioned product is gluten free and has not been formulated or exposed to gluten-containing grains such as wheat, rye, barley, or oats.

CMR Statement:

Natural Certification:

Bio-Botanica, Inc. confirms that the above-mentioned product complies with the FDA's informal definition for "Natural" which states that nothing artificial or synthetic has been included or added.

The material does contain Propylene Glycol, but this ingredient is an accepted component of natural flavors.

RSPO Statement:

Bio-Botanica, Inc. confirms that the product mentioned above is made with Glycerin that is derived from RSPO certified Palm Oil.

Non-Irradiation/ETO Statement:

Bio-Botanica, Inc. confirms that the materials used in the manufacture of the above-mentioned product have not been handled by, exposed to, or have been treated with irradiation, Ethylene Oxide (ETO), nor sewage sludge. This statement is based on supplier information, routinely updated by Bio-Botanica.

PFA, Microplastics, and Nitrosamines Statement:
