This product contains Benzyl Alcohol, Eugenol, Isoeugenol, Beta-Caryophyllene, Eugenia Caryophyllus Oil, and Eugenyl Acetate which are naturally occurring in Clove Flower Bud Extract.

Genetically Modified Organisms:

Bio-Botanica, Inc. confirms that none of the ingredients used in its preparation or manufacturing of the above-mentioned product has been subject to or derived from genetically modified sources. It is also free from both genetically modified DNA and the proteins derived from genetically modified DNA.
