This product does not contain any of the 26 substances listed in the EU Cosmetics Regulation 1223/2009

Genetically Modified Organisms:

The above-mentioned product contains propanediol that is derived from corn. Due to high refinement used in the manufacturing process of the raw material, no GM or DNA would be detectable in measurable amounts. However, we note the corn used to produce propanediol may or may not be sourced from GM corn.

As a result, we are unable to support a Non-GMO status. To the best of our knowledge, the final product is GMO free.

Vegan/Vegetarian:

Bio-Botanica, Inc. confirms that the above-mentioned product is vegetarian/vegan. No raw materials with animal derivatives have been used in the manufacturing of this product.

BSE/TSE Statement:

Bio-Botanica, Inc. certifies that the ingredients in the above-mentioned product is not derived in whole or part from animal sources and does not utilize animal derivatives in its manufacture. Additionally, this material complies with the FDA interim rule effective January 12, 2004 (9 CFR Parts 309, 310, 311, 318 and 319) regarding prohibition

of Specified Risk Material (SRM) for human food and Requirements for the Disposition of Non-Ambulatory Disabled Cattle. This product is non-BSE & non-TSE.

Prop 65:
