Prop 65:

Bio-Botanica, Inc. confirms that the above-mentioned product is compliant with the State of California's Proposition 65; whereas, to the best of our knowledge, this product does not contain any chemical known to the State of California to cause cancer, birth defects or other reproductive harm.

Animal Testing/Cruelty Free:

Bio-Botanica, Inc. confirms that the above-mentioned product has not been subject to animal testing and is considered cruelty free.

GRAS Status:

Natural Certification:

The materials used to produce the above-mentioned product does not comply with the definition given to a "Natural Ingredient" by the FDA. The Butylene Glycol used in this product is produced synthetically.

Non-Irradiation/ETO Statement:

Bio-Botanica, Inc. confirms that the materials used in the manufacture of the above-mentioned product have not been handled by, exposed to, or have been treated with irradiation, Ethylene Oxide (ETO), nor sewage sludge.

PFA, Microplastics, and Nitrosamines Statement:

Bio-Botanica, Inc. confirms that based on the manufacturing process of the above-mentioned product, the presence of PFAs, microplastics, and nitrosamines is not expected, nor are they intentionally added, even though these substances are not currently measured.
